The Irish Rebellion.

Friends of Mr. Clay out for Gen. Taylor.
Nineteen Clay men at Albany, who were opposed to the nomination of Taylor, and who were officers of the late Clay meeting in that city, have now come out in favor of Old Zack. The last letters of Gen. Taylor and the Sage of Ashland have wrought the change.

Discovery of a New Satellite.
At the Cambridge Observatory, on the evening of the 22d ult., the discovery of another satellite to the planet Saturn took place, making the eighth. William Cranch Bond, the eminent astronomer of Cambridge University, and his son and assistant, George Bond, were the fortunate discoverers.

Mysterious Disappearance of a Vessel.

Death of a U. S. Consul.
Wm. A. Leidesdorf, late U. S. Consul at St. Francisco, California, died there on the 18th of May, after a short illness.

A Fire in New York.

James Young, first lieutenant and chief of the Philadelphia police department, has been suspended from official duty, in consequence of his implication in the knowledge of the perpetrators of the robbery of Dr. Darlington, President of the West Chester Bank, and an alleged participation in the proceeds of that daring felony.

Ed. Crescent.—This is a fair probability of the "managers" of the whig party here coming into selection for the honor of Taylorism. Mr. N. B. Jones, however, is a man of high standing, and though no one knows exactly if he will be the next choice, it would not be very surprising if it were Mr. Greeley himself. His paper has had an unusual quieting that way of late. The separate nominations for State office by the whigs, bankers and barons, have created considerable dissatisfaction, and the result of the election will be a fair test of the whig party. There is the great probability of Fish's election, and whig success in the Legislature, which will result in some handsome appointments.
