THE SELKIRK AMERICAN SETTLEMENT.—The Boston Traveller gives a very interesting description of the settlement of Scotch Highlanders under the auspices of Lord Douglas, Earl of Selkirk, on the Red River, in the British possessions. The present number of inhabitants is about 7000, including the Indian settlement, which contains 600-800 Creeks or Kisteneau, and 100 Ojibwas. There are, however, only fifty families of Scotch, many of their countrymen having retired to the United States and Canada during the days of their adversity. There are also a few English and Orkney men, but the greater part of the inhabitants are half natives, descendants of fur traders and their servants, of native women.
