The schr. Lone Star, from Velasco for Galveston, with 120 bales of cotton, was wrecked on the beach, near Lone Star Island, a few days since. She has been damaged, and the wreck and cargo advertised to be sold.

FOR CONGRESS, in this district, Howard has about 8000, Williamson 2000, Fishers 2000, and McLeod about 2000 votes, as far as heard from. Perhaps a thousand votes remain to be reported; but there is no prospect of any material change in the relative vote of the candidates. The vote of the State will probably be about 25,000—Galveston Division.

The positions adopted by both are, that Congress has control over the Slavery question in the District of Columbia and the Territories, but not in the States. Mr. Polk's signature to the Oregon bill is approved.

New York Politics. The Hunker (or Cass) State Convention of the New York democrats, after nominating a full ticket, on the 5th, excluding the Barnburners, passed a resolution offering conditionally to withdraw one-half and support the Barnburners, who might be nominated at that convention to fill the vacancies.

The condition was that no test should be imposed upon the candidates, inconsistent with the resolutions adopted by the Hunkers at Rome, on the subject of slavery. These resolutions were declaratory of the power of Congress on the subject of slavery in the territories, a wish that it might be exercised, but a determination not to make it a test of party.

The regular Barnburner Convention met at Utica on the 10th. We have only a telegraphic notice of its proceedings, which announces that a union was formed upon the basis proposed. In other words, the Barnburners accepted the nomination of the Hunkers, for Commissioner, Attorney General, Canal Commissioner, and State Prison Inspector, and nominated candidates of their own for Secretary of State, State Treasurer, State Engineer, and Judge of the Court of Appeals.

If this union be made, as reported, it is practically a concession by the Cass party to the demands of the free-soilers. The mere resolution that the slavery restriction is not to be made a party test, amounts to nothing except to save pride. Recognition of the power of Congress over the subject, and the testimony given to the moral duty of exercising it, leave no doubt that the whole action of the party will be given in favor of the exclusion of slavery from the territories by act of Congress.

The course of the party will be decided by its representatives. The individual opinions of a few, against the exercise of the admitted power, will be overruled by the preponderance of numerical force in favor of action, and the power of regular nominations will carry the whole body in that direction. If the Cass democrats have, as is reported, joined with the free-soil men, the whole party may be set down as in favor of the action of Congress to exclude slavery from the territories.

Another result is that there is no longer any organized party in New York, if in any Northern State, favorable to the Southern view of the want of power in Congress to legislate for this exclusion. Of the three parties lately existing there, two—the whigs and the free-soilers—have agreed in the public affirmation of the constitutional power and the duty to exercise it. The regular democrats have, heretofore, avoided or refused to make any such pledges, and generally insisted, as the most politic way of getting rid of the question and all its embarrassments to them, on the doctrine of non-interference; in some quarters insisting that it was inexpedient, and in others unconstitutional, to impose the restriction. Should it be true, as the telegraph communicates, that the Hunker and Free-soil conventions have united, and that the union extends to the mass of voters, then it may be set down as certain, for the consideration of the Southern States and people, that the State of New York, by common consent of all parties, is ranged unobscurely in favor of a law of Congress forbidding the existence of slavery in California and New Mexico.
