COVINGTON, LA., Jan. 12, 1881.

The Police Jury met at the Courthouse on the above date.

Present—J. M. Allison, President; Paul Dulion, W. B. Rogers, W. E. Parker, Milton Barnum, M. H. Cray.

Absent—C. Aubry, A. Cousin, Jas. W. Smith and Pat Welch.

The reading of the minutes of the last meeting was dispensed with.

The following ROAD OVERSEERS were then appointed to serve for the present year:

First Ward—On the Bridge road, from Madisonville to Covington, Thos. Perrin.

On the Ferry road, from the junction to Covington, Thomas Badaux, Jr.

On the Turnpike road, from the upper end to Gum Pond, Preston Bennet.

On the Ponchatoula road, from Theo. Danziger's store to the parish line, John Englehart.

Second Ward—On the Kimball road, to extend to the Franklinton road, Step Blackwell.

Holmesville road, from the corporation line of Covington to the seven mile post, Emile Brubel.

Holmesville road, from the seven mile post to the parish line, Martin Blackwell.

Edwards road, from Elwaris' bridge to the nine mile post, on the Holmesville road, Jack Yates.

Lee road, from seven mile post on Holmesville road to Tchefaneta bridge, Louis Bernard.

Core road, from Holmesville road to parish line, John Troscette.

Third Ward—From Bogue Falia bridge to Ponchatoula bridge, on Mandeville road, Fritz Zone.

Pearl River road, from Bogue Falia bridge to the Abita bridge, John Labat.

Columbia road, from Bogue Falia bridge to the ward line, Aleck Page.

Lee road, from corporation line to the ward line, D. C. Levy.

PETITIONS. COVINGTON, LA., Jan. 12, 1881.

To the honorable President and members of the Police Jury:

Gentlemen—The petition of divers inhabitants of the Third ward, in this parish, humbly sheweth that your petitioners labor under great inconvenience for want of a road or highway to lead from Covington to Bogue Chitto. The road asked for is to leave the Military road, between the one and two mile posts, to pass to the left of Bazz rd pond, thence to L. D. Davis's place, passing through his lane, thence to Tyson's place, to the right, thence to the head of Long Branch, leaving it to the left, thence to the old Spanish ford, on ten mile branch, thence to the Abita crossing, near the Lone Hickory.

Petitioners further ask that they be relieved from road duty on other public roads, and that they be transferred to work on said road as asked, and that an overseer be appointed for the same.

On motion, the above petition was granted, and Mr. L. D. Davis appointed overseer of said road.

The following

New Public Road Law

was then read and adopted, and the Secretary instructed to furnish each Road Overseer with a copy of the same, which is to be returned with his report:

No. 112.] AN ACT

To amend and re-enact Section 3373 of the Revised Statutes of 1870, relative to public roads.

Re it enacted by the General Assembly of the State of Louisiana, That Section 3370 of the Revised

Statutes be and the same is hereby amended and re-enacted so as to read: "It shall be the duty of the Police Juries to divide their parishes into as many districts as they may think proper, for the appointment of overseers of roads. They shall, annually, appoint overseers of highways or roads, who are to summon all male persons, from the age of fifteen to fifty, [except ministers of the gospel and such other persons as are or shall be exempt], to meet at such places and times, as to them, the said overseers, shall seem convenient to work on the public roads; and whosoever shall, upon such summons, refuse or neglect to do and perform their duty, shall forfeit and pay the sum of two dollars per day for each person so neglecting or refusing, to be recovered by judgment before any justice of the peace of the parish, and paid by said justice to the overseer and by him to be expended in hiring other hands to work on said roads, and in default of refusal to pay such fine, such person shall be confined in the parish prison until such fine is paid; provided, he shall not remain in prison for more than five days.

RESOLUTIONS ADOPTED. The following resolutions were adopted.

Resolved, That the warrants of the Secretary be made receivable for the general fund tax of five mills.

Resolved, That hereafter the members of the Police Jury be paid for their services, in accordance with the resolution adopted at the May meeting, 1880—\$3 per day and five cents mileage.

Resolved, That the Treasurer be instructed not to register any warrants hereafter, except for the persons to whom the same are issued.

Resolved, That the Sheriff be instructed to proceed with the collection of the parish delinquent taxes, in accordance with the State law.

Resolved, That the Sheriff be instructed to proceed at once with collection of all Parish licenses for the present year.

Resolved, That the bid of Ely Namburger, for the lease of the Bayou LaCombe ferry, for the sum of ten dollars, be accepted, the contract to continue five years from the 13th of September, 1880, and that the Secretary be instructed to notify him of the same.

Resolved, That all warrants that are receivable for taxes and licenses be received only for the year in which the services for the same were rendered.
