## TERMS OF COURT.

### CIRCUIT COURT.

It is hereby ordered that the rule of Court, rendered April 6, 1880, be and the same is hereby amended, as follows: From and after July first, 1882, the terms of Court of the several parishes composing the Eighteenth Judicial District shall commence on the following dates:

Parish of Tangipahoa.

Jury terms—Second Monday in January and first Monday in June. Court terms—Fourth Monday in April and second Monday in November.

Parish of Washington.

Jury terms—Fourth Mondays in January and June. Court terms—Second Monday in May and first Monday in December.

Parish of Livingston.

Jury terms—Tuesday after the second Monday in March, and Tuesday after the fourth Monday in October. Court terms—Tuesday after the second Monday in April, and Tuesday after the fourth Monday in November.

Parish of St. Tammany.

Jury terms—Fourth Monday in March and second Monday in October. Court terms—Fourth Monday in May and third Monday in December.

## PROCEEDINGS

## POLICE JURY

—OF—

## St. Tammany Parish.

Covington, La., March 26, 1883.

The Police Jury met on the above date.

Present—J. M. Allison, M. Burns, R. Galatas, W. B. Rogers, W. E. Parker, P. Welch and Chas. Aubry. Absent—A. Cousin and M. H. Crary.

The minutes of the last meeting were read and approved.

On motion, the Secretary was authorized to issue warrants to the commissioners, returning officers and clerks of election.

The bills of justices of the peace and constables were laid over till next meeting, and they were requested to make out their bills according to law.

The following estimate of the expenses of the parish for the year ending December 31, 1883, was adopted:

The following Ordinance was then adopted:

Be it ordained, by the Police Jury of St. Tammany Parish, That there shall be levied, for the year 1883, a tax of two mills on the dollar for the Public School fund; a further tax of two mills on the dollar for expenses in Criminal matters; a tax of one-half mill on the dollar for repairs to the Courthouse; and a tax of five and one-half mills on the dollar for the general expenses of the parish.

Be it further ordained, That the Sheriff and Ex-officio Tax Collector be and he is hereby instructed to collect, on all the taxable property of the parish, the corporations of Covington, Mandeville and Madisonville included, the two mill tax levied for the School Fund, the two mill tax levied for expenses in Criminal matters, and the one-half mill tax levied for repairing the Courthouse; and that said taxes be collected in currency and paid into the hands of the Parish Treasurer.

Be it further ordained, That the Tax Collector shall receive, in payment of the five and one-half mill tax levied for the general expenses of the parish, and for the parish licenses, the certificates of Grand and Petit Jurors, the certificates of Witnesses, and all approved bills of the Police Jury, of the current year 1883.

On motion, the Tax Collector was instructed to proceed at once with the collection of the Parish taxes and licenses, in accordance with the above ordinance.

The following proposal for repairing the Courthouse was read:

Covington, La., March 25, 1883.

To the honorable President and members of the Police Jury:

Gentlemen—I propose to furnish all the material, and do the work of repairs on the Courthouse, as per advertisement, and do the same in a good and workman-like manner, all for the sum of two hundred and twenty-five dollars. Respectfully,

W. W. RISHER.

On motion, the following resolution was then adopted:

Resolved, That the bid of Mr. Risher be accepted, and that he be required to give a bond in the sum of \$450, for the faithful performance of the work, subject to the approval of the committee on repairs to the Courthouse.

The President appointed the following committee to examine the warrants and accounts of the Parish Treasurer, keep a record of the dates and amounts of the same, and pay the same, give the receipt for the same, and furnish

copy of their report for publication: Messrs. Parker, Rogers and Aubry.

Mr. N. Levy offered the sum of ten dollars for the right to run a public ferry at Bonfouca, for five years from date, (March 26, 1883,) which was accepted.

On motion, the salary of the Parish Treasurer was increased to \$200 per year.

R. Starks, from Hickory creek to the center of Gum creek bridge.

T. G. D. Richardson, from the Talishek to the Columbia road.
