

## CHARTER.

United States of America, State of Louisiana, Parish of St. Tammany.

BE IT KNOWN, That on this day, the thirteenth of the month of September, in the year of our Lord one thousand nine hundred and one, before me, H. K. Warren, clerk of the District Court and Ex-Officio Notary Public for the said Parish of St. Tammany, and in the presence of the witnesses hereinafter named and undersigned, personally came and appeared the several persons whose names are hereunto subscribed, who severally declared that, availing themselves of the provisions of the laws of this State, they have covenanted and agreed, and do hereby covenant and agree, to form and constitute themselves and their successors into a corporation for the following objects and purposes, and under the following conditions and stipulations, viz:

Article I.  
Said corporation shall be known and designated as: Southern Industrial Institute, limited, and under said name it shall exist and enjoy succession for a term of ninety-nine years from this date, and exercise and enjoy all powers and privileges granted now or hereafter by law unto corporations.

Its domicile shall be in Covington, Parish of St. Tammany, Louisiana, and all citations or other legal process shall be served upon the President, or in case of his absence, upon the Secretary-Treasurer.

Article II.  
The purposes for which this corporation is established, and the nature of its business, are declared to be the manufacture and sale of boots, shoes, articles of personal wear, household furnishing goods, and all articles connected with such business, and also the conduction of a printing office.

Article III.  
The capital stock of this corporation is hereby declared to be the sum of fifty thousand dollars, divided into or represented by two thousand shares of twenty-five dollars each. Said stock shall be subscribed for and paid in cash, and same may be issued for property actually received or labor done for said company. Transfers of stock shall only be made on the books of the company by a stockholder, in person or by proxy, but none shall be sold or transferred by any stockholder unless the said stock shall have been first offered for sale to the other stockholders at the same price offered unto others, through written notice served upon the President of the company, and only upon the failure or neglect of the other stockholders to avail themselves, within ten days, of such right to purchase, shall such stock become transferable.

Article IV.  
The business of this corporation shall be managed and all its corporate powers shall be vested in a board of directors, composed of seven stockholders to be elected annually on the first Monday in May, commencing with the year of 1902. At their first meeting in each year, said board shall elect one of their members as President, one as Vice-President and another as Secretary-Treasurer.

At all elections for directors, the persons receiving the votes of the majority of the stock present, or represented, shall be declared elected, and at all meetings of the board or directors there shall constitute a quorum. Said board of directors shall have authority to fill all vacancies occurring in their own number by death, or resignation, or otherwise, and shall have full power to appoint such managers as may be necessary for the proper government of the affairs of the corporation, and the same to dismiss at pleasure, and also to make and establish, as well as change and alter, at pleasure, all such by-laws, rules and regulations for the support and management of the affairs of said corporation, as they may deem necessary; to borrow money, execute mortgages, issue bonds, make contracts, and do all things necessary in the transactions of the business of the corporation; to purchase and sell real estate, as also to issue and deliver full paid shares of the stock and bonds or obligations of said corporation, at not less than par, for labor done, or money, property, or rights, actually received by it.

Article V.  
All elections for directors shall be held on the first Monday in May of each year, as above stated, commencing with the year 1902, under the supervision of three commissioners, of which election ten days notice shall be published in a paper published in the Parish of St. Tammany. A failure from any cause to hold an election for directors on the day above specified shall not dissolve said corporation, but those in office shall hold over until their successors shall have been elected, and another election shall be called or held within ten days, of which notice shall be published in a newspaper published in said Parish of St. Tammany.

Article VI.  
This Act of Incorporation may be amended, altered, or changed, or said corporation may be dissolved at a general meeting of the stockholders convened for that purpose, after fifteen days public notice in one of the newspapers published in said Parish of St. Tammany, at which meeting, the opinion of three-fourths of the stock present, or represented, shall prevail; and in case of dissolution, the stockholders

shall elect three stockholders to liquidate and settle the business and affairs of said corporation. In case of death or resignation of one of said Commissioners, the survivors shall select another stockholder to fill the vacancy. Said corporation may be dissolved at any time, without publication or notice, by the unanimous consent of all its stockholders.

Its capital stock may be increased in the manner prescribed by law, to such amount as may be determined by the stockholders in general meeting convened, or in like manner decreased.

Said corporation shall have the right to begin business as soon as four hundred shares are subscribed.

## Article VII.

No stockholder shall ever be held liable, or responsible, for more than the unpaid balance on stock subscribed, nor shall any mere informality in organization render this charter null, or expose any stockholder to any liability beyond the amount of his stock.

## Article VIII.

Messrs. C. Z. Williams, M. D., Peter Fabacher, Fr. Gabriel Ruppert, H. J. Smith, J. S. Jones, E. J. Frederick, D. J. Harney, with said C. Z. Williams, M. D. as President, and said Fr. Gabriel Ruppert as Secretary-Treasurer, shall constitute the first Board of Directors, and they shall serve until the first Monday in May, 1902, or until their successors shall have been duly elected.

Thus done and passed in my office, at Covington, in said Parish of St. Tammany, on the day, month and year first above written, in the presence of Louis J. Heintz and W. E. Blossman, competent witnesses of lawful age, and residing in this parish, who herewith sign their names with said parties and me, the said officer, after due reading of these presents.
