Robertson at Donaldsonville.

Col. S. M. Robertson opened his campaign at Donaldsonville last Sunday. A large crowd was in attendance.

President Brand introduced Hon. R. M. Sims as the first speaker. Mr. Sims laid particular stress on and denied in strong language the report of dissension in the Democratic Party of Ascension. He denied the slander that the Democratic Party intended to countenance any fraud on election day. He invited the Republicans to witness the count, and he dared them to challenge the fairness of the election.

Col. F. Sambola Jones, of Baton Rouge, was the next speaker. Louisiana's only hope, he said, laid with the Democratic Party. If there was any glory, any honor, in Louisiana, it was written by the Democratic Party; and all the shame, all the disgrace, was written by the Republican Party. No party that was sired by republicanism can be respectable. Col. Jones interspersed his address with many anecdotes.

A flattering reception was tendered Congressman Robertson when he arose. For sixteen years, said he, he had represented the people in Congress, and for nine years he had received the Democratic nomination, and he was proud of the service he had rendered the people. Congressman Robertson reviewed the history of sugar, showing how the Democratic Party had taken sugar off the free list, where it had been placed by the Republican Party, and placed it on the dutiable list. Mr. Robertson read extracts from the minutes of congressional sessions, showing the difference between the policies of both parties. He retorted Mr. Hebert's reference to the Democratic text-book, and referred to the action of the Iowa Republican Convention, showing the drift of republicanism. Mr. Robertson's elucidation of the tariff was to the point and convincing. He referred to Coleman, the erstwhile Republican congressman, who had voted against the Republican tariff bill. He referred to Roosevelt's reciprocity, and showed how reciprocity was killed through the work of the Democratic Congressmen from Louisi-

ana. The Republicans had said that there was nothing in reciprocity, and if so, he would ask why Behan, McCall and others had gone to Washington, and had maintained a lobby there? They found this action necessary, and under a Republican administration. He ridiculed candidate Hebert's platform showing its inconsistency in endorsing Roosevelt in one breath and denouncing the President's reciprocity in the other. Regarding the trusts, he would guarantee that when the Democratic Party got into power there would be no beating around the stump as there is now with the Republican party.

LOUISIANA BAR

Against Court of Appeals Amendment.

A meeting of the Louisiana Bar Association was held in the library of the Civil District Court, in New Orleans, last Monday afternoon, for the purpose of adopting resolutions on the proposed amendments to the laws governing the judiciary department of the State, the principal purpose of which is to limit the Supreme Court's jurisdiction to matters involving not less than \$5000. At present the court has jurisdiction in matters as low as \$2000. These amendments are to be voted on at the election in November, and it was unanimously decided by the meeting to disapprove the amendments.

A committee composed of the following gentlemen was appointed: Messrs. Kruttschnitt, Merrick, McGloin, Hart, Fenner, McCaleb and Forman. They will decide upon some course by which to give publicity to the action of the association to instruct the voters in the premises.

An Ordinance

Forbidding the Selling of Game.

Be it ordained by the Police Jury of St. Tammany, That it shall be unlawful for any person to sell, barter, or exchange any deer, wild turkeys, quail or partridges, to any merchant or other person within the confines of the Parish, or any other place in the State of Louisiana. That any person violating the provisions of this law shall be deemed guilty of a misdemeanor, and if found guilty be fined in sum of not less than \$10 nor more than \$100, and in default of payment of fine and costs he shall be imprisoned in the Parish jail, not to exceed 60 days.
