FIRE ALARMS.

As Arranged for the Covington Fire Department.

Explanation: The system of the St. Tammany Ice & Manufacturing Company's whistle will be as follows: For instance, if an alarm is given from District No. 12, the whistle will blow once, then a pause of five seconds and the whistle will blow twice—No. 13.
