BREWSTER ANNOUNCES HE WILL BE A CANDIDATE.

Sheriff T. E. Brewster makes announcement in this issue of The Farmer that he is a candidate for re-election. This announcement will be gladly welcomed by his many friends throughout the parish and by all who are familiar with his conduct of the office during the several terms of his service.

Few men have passed through the political strife incident to the contest for public office without being soiled by splashes of mud thrown during the campaign. We have yet to hear of a single thing said in derogation of Mr. Brewster's character even by his bitterest enemy.

With a dependable sheriff and a dependable judge, the great fundamentals of democratic existence, security of life and property and the pursuit of happiness, are enjoyed to their fullest extent. We know what we have. Experience has given us the trust and confidence that can be gained in no other way.

OUR REPRESENTATIVE IN THE LEGISLATURE.

The rapid recurrence of elections for legislative members, with the inevitable expense of campaigning, makes the position of considerable financial burden to one of ordinary means, with the tendency of withdrawing this honor from many men of ability who would otherwise seek it.

Mr. Helntz has shown no inclination to be governed by other than a conscientious desire to perform his duty. He has not been found on the side of cliques and factions. He has opposed lobbying and through his instrumental lobbyists have been debarred from the floor of the house.

As Mr. Helntz has announced that he will be a candidate for re-election, we are pleased to note that he has thus far no opposition, and we trust that he will have none, for while he stands a good chance for re-election the expense incident to a campaign is a financial weight we would like to see him spared.

THE BROCK-LANCASTER CONTROVERSY.

On the first page of The Farmer has appeared for the past two weeks a discussion between District Attorney Brock and W. B. Lancaster relative to the violation of liquor laws in Mandeville. We do not wish to discuss the legal points of this controversy, but we wish to call attention to a peculiar situation that has brought into prominence as a violator of the law the most inoffensive and orderly barroom in Mandeville.

The Bechac & Mugler barroom was supposed to be opened with the consent of the property holders within 300 feet, in accordance with law, and a permit was obtained and a license issued by the Town of Mandeville. Subsequently Mr. Geo. Rene, of Mandeville, disputing that the required number of property holders within 300 feet had signed the petition, brought the matter into the District Court by his attorney, Mr. Moise, and the Court decided that the objection must come from the property holder or holders within the prescribed 300 feet.

The Bechac & Mugler barroom is situated in the annex to the Mugler Hotel, the largest and most prominent in Mandeville. It is just off from the dining room. Last Tuesday we visited the place and took luncheon there. A party of ladies, including some children, were being served at an adjoining table. We visited the barroom after luncheon and were impressed with the quiet and orderly appearance of the place.

As for the general violation of the liquor law, there may be little doubt. It has been commented upon in every town that has a barroom. From the best of our information, Slidell comes nearer to observing the law than any other place. But the only ones who may be witnesses to these violations are those who frequent the barrooms and assist in the violations. It is a difficult matter to sift them out and force them to testify.

We find no fault with Mr. Lancaster's effort to have the laws enforced, but we believe the means employed are ineffectual. The police regulation of barrooms in incorporated towns should be up to the towns themselves. They have the power to pass ordinance not in conflict with the State laws and to enforce them, and being on the grounds have opportunity to gather the information necessary to convict for violations.
