Tax Sales

State of Louisiana, Parish of St. Tammany vs. Delinquent Tax Debtors.

By virtue of the authority vested in me by the Constitution and Laws of the State of Louisiana, and Act No. 224 of the General Assembly of 1910, I will sell at the principal front door of the courthouse, in the town of Covington, Louisiana, within legal sale hours for judicial sales, beginning at 11 o'clock a. m., on

Saturday, June 22, 1918,
