

Tax Sales

State of Louisiana, Parish of St. Tammany vs. Delinquent Tax Debtors.

By virtue of the authority vested in me by the Constitution and Laws of the State of Louisiana, and Acts of the General Assembly, I will sell at the principal front door of the courthouse, in the Town of Covington, Louisiana, within legal sale hours for judicial sales, beginning at 11 o'clock a. m., on
