Be it ordained by the Police Jury, in legal session convened, That: all that part of the Parish of St. Tammany lying east of Pearl River, commencing at the mouth of Pearl River east of the Rigolets and Lake Shore to the southwest corner of section 11, tp 10 s, range 14 east; thence north of section line to the southwest corner of section 35 tp 7 s, range 14 east; thence east on township line to southeast corner of the southeast corner of southwest corner of section 31, tp 7 s, range 15 east; thence north through center of section 31 to north boundary line of section 31, tp 7 s, range 15 east; thence east on section line to corner common to sections 29, 28, 32 and 33, tp 7 s, r 15 east; thence north of section line to corner common to sections 20, 21, 28, and 29, tp 7 s, r 15 east; thence east on section line between sections 21, 28, 22 and 27, tp 7 s, r 15 east, to west bank of Pearl River; thence down Pearl River to the place of beginning, shall constitute the Eighth Ward of the Parish of St. Tammany.

Be it further ordained, that all ordinances contrary to or inconsistent with this ordinance are hereby repealed insofar as they conflict herewith but not further.
