

# Tax Sales

State of Louisiana, Parish of St. Tammany vs. Delinquent Tax Debtors

By virtue of the authority vested in me by the Constitution and Laws of the State of Louisiana, and Act No. 221 of the General Assembly of 1910, I will sell at the principal front door of the courthouse, in the Town of Covington, Louisiana, within legal sale hours for judicial sales, beginning at 11 o'clock a. m., on Saturday, September 9, 1922, and continuing on each succeeding day until said sales are completed, all immovable property upon which taxes are now due the State of Louisiana and Parish of St. Tammany, to enforce payment of taxes assessed in the year 1921, together with the interest thereon from the 31st day of December of said year, at the rate of 2 per cent per month until paid, and all costs.
