TO ALL CLAIMANTS OF LAND IN THE HAWAIIAN ISLANDS.

THE undersigned have been appointed by His Majesty the King, a board of commissioners to investigate and confirm or reject all claims to land arising previously to the 10th day of December, A. D. 1845.

Patents in fee simple, or leases for terms of years, will be issued to those entitled to the same, upon the report which we are authorized to make, by the testimony to be presented to us.

The board holds its stated meetings weekly, at Hale Kauwila, in Honolulu, island of Oahu, to hear the parties or their counsel, in defence of their claims; and is prepared, every day, to receive in writing, the claims and evidences of title which parties may have to offer, at the office of Joseph Henry Smith, Esq., Secretary of said Board, at Hale Kauwila, in Honolulu, between the hours of 9 o'clock A. M. and 3 o'clock P. M.

All persons are required to file with the Board by depository with its Secretary, specifications of their claims to land, and to adduce the evidence upon which they claim title to any land in the Hawaiian Islands, before the expiration of two years from this date, or in default of so doing, they will after that time be forever barred of all right to recover the same, in the courts of Justice.

2d. That Joseph Henry Smith, Esq., be employed as one of our stated Secretaries, at a compensation to be hereafter determined, derivable solely from the fees and perquisites resulting to Government from the labors of this Board.

3d. That said Secretary be duly sworn to fidelity in the discharge of his duties as such. That he be, and is hereby authorized to receive claims and evidences for our after consideration, from and after the first publication hereof. That he be required to endorse upon each claim the day and hour of its receipt by him. That he keep an office at Hale Kauwila, in Honolulu for the transaction of his duties and for the facility of claimants. And that he be charged with keeping the Minutes of this Board and of its proceedings upon claims.

4th. That claims submitted for settlement be taken up and acted upon according to the order of their presentations, and be settled pursuant to order taken in each case by a majority in number of this Board.

5th. That the stated meetings of this Board be held on Wednesday of each week, commencing at 9 o'clock A. M., at the said office at Hale Kauwila, in Honolulu, for the transaction of business. The first meeting to be held on the 4th day of March next.

6th. That these Resolutions be published in the Polynesian Newspaper, concurrently with the notice to claimants, required by law, to the end that they may be apprised of these By-Laws established by the Board.

BY AUTHORITY.

JOINT RESOLUTION.

Resolved, by the Nobles and Representatives of the Hawaiian Islands, in Legislative Council assembled.—

1st. That from and after the respective dates herein- after mentioned, to be computed from and after the publication of this resolution in the Polynesian newspaper, the act, parts of an act, chapters, titles and articles mentioned herein, and finally passed on the 27th day of April, 1846, shall take effect and become the binding law of this kingdom; and that from those dates respectively, all other laws in conflict therewith shall be, and they are hereby repealed—that is to say:

SECOND ACT KAMEHAMEHA III.,

Entitled "an Act to Organize the Executive Departments of the Hawaiian Islands"

PART I. Entitled department of the interior: consist'g of CHAPTER I. Of the government press, consisting of article 1; government press. Article 2; public stamps. Article 3; directors accountability.

CHAPTER II. Internal commerce, consisting of article 1; vendors of goods, wares and merchandise. Article 2; vendors of spirituous liquors. Article 3; hotels and victualling houses. Art. 4; public auctioneers. Art. 5; hawkers and peddlers. Art. 6; newspapers and periodicals.

CHAPTER III. Internal improvements, consisting of article 1; public roads, highways and bridges. Article 2; public marts and markets. Article 3; lighthouses, beacons and channels. Article 4; prisons and houses of correction. Art. 5; the restraining and impounding of estrays.

CHAPTER IV. Gubernatorial transactions, consisting of article 1; the marriage contract. Article 2, citizens and separations. Article 3, enlistment of native sailors on board foreign vessels. Article 4; the apprehension of fugitives from justice. Article 5, the civil posse and the military power. Article 6; the government property. Art. 7; discretionary duties. Art. 8; prescribed duties.

CHAPTER V. Subjects and foreigners, consisting of article 1; aliens, denizens and natives. Article 2; departure of foreigners. Art. 3; the assets of inter-state foreigners.

CHAPTER VI. The inter island channels, coasting trade and fisheries, consisting of article 1; the maritime coast and enclosed seas. Article 2; the registry of Hawaiian vessels. Article 3; the coasting trade. Article 4; the inter island mails. Article 5; the public and private rights of piscary.

CHAPTER VII. The Hawaiian land office, consisting of article 1; the cession of private lands to government; article 2; the disposition of government lands; article 3, the real rents, forfeitures and escheats; article 4; the board of commissioners to quiet land titles.

PART II. Entitled Department of foreign relations: consisting of CHAPTER I. The foreign agency.

CHAPTER II. The neutral and belligerent rights. CHAPTER III. The home duties to foreign nations, consisting of article 1, the apprehension of fugitives from justice; article 2, the foreign departures; article 3, the assets of inter-state foreigners; article 4, the registry of Hawaiian vessels; article 5; the real escheats.

PART III. Entitled department of finance: consisting of CHAPTER I. The foreign imports, consisting of article 1, the arrival of foreign vessels; article 2, the departure of foreign vessels; article 3, local regulations applicable to the respective ports; article 4, tariff of imports, fees and expenses incident to chapter 1, part 3; article 5, tariff of compensations incident to chapter 1, part 3; article 6, accountability of officers under chapter 1, part 3.

CHAPTER II. Internal taxes, consisting of article 1, of the poll tax; article 2, the land tax; article 3, the labor tax; article 4, taxable chattels and chattel taxes; article 5, the assessment of taxes.

CHAPTER III. Departmental fees, perquisites, costs, &c., consisting of article 1, prescribing fees for the department of interior; article 2, prescribing fees for the department of foreign relations; article 3, prescribing fees for the department of public instruction; article 4, prescribing fees for the department of law; article 5, the audit and settlement of accounts in general.

CHAPTER IV. Coins and currency, consisting of article 1, interest; article 2, weights and measures.

CHAPTER V. Of the fines, penalties and pecuniary civil forfeitures. CHAP. VI. Government realizations.

PART IV. Entitled department of public instruction: consisting of CHAPTER I. Parental duties.

CHAPTER II. Filial duties. CHAPTER III. The public and private schools. CHAPTER IV. Institutions endowed by government. CHAPTER V. Parish and church foundations. CHAPTER VI. Penal obligations in regard to children, schools and churches.

PART V. Entitled department of law; consisting of TITLE I. Duties to the legislative branch of government. TITLE II. Duties to the executive branch of government: consisting of

CHAPTER I. The executive judicial officers. CHAPTER II. The executive extra judicial officers, consisting of article 1, registry of conveyances; article 2, registry of wills and testaments; art 3 the notarial duties. CHAPTER III. The legal suits and defences. CHAPTER IV. Criminal Prosecutions.

Together with the general provisions of said respective parts; and the general provisions of the said entire act.

2. And be it further resolved, That the first part of said act shall take effect immediately upon the publication hereof as aforesaid. Excepting so much thereof, and of the second and third parts, as require aliens, coming to reside in this kingdom, to bring and exhibit passports, which requirement shall not take effect until the full expiration of one year after such publication. Excepting also sections 7 of article 4 of chapter 6 of said first part which shall not take effect until the proclamation of His Majesty in privy council, ordered for that purpose; and also excepting article first of chapter 4 of the said first part entitled, "Of the marriage contract," which shall not take effect until the expiration of ninety days from the publication hereof, as aforesaid.

3. And be it further resolved, That the second part of said act shall take effect immediately after the publication hereof.

4. And be it further resolved, That the third part of said act shall take effect at and after the expiration of sixty days from the publication hereof. Excepting article first, second, third and fourth of chapter third; entitled of "Departmental fees, perquisites, costs, commissions, &c.," which shall take effect immediately upon the publication of this resolution.

5. And be it further resolved, That the fourth part of said act shall take effect at and after the expiration of ninety days from the publication of this resolution.

6. And be it further resolved, That the fifth part of said act shall take effect at and after the expiration of sixty days from the publication hereof, excepting chapter third entitled "Of the legal suits and defences," which shall go into effect immediately after the publication of this resolution; and that until the passage of the act to organize the judiciary, the judge or judges appointed for Honolulu in conformity with article fifth of the general provisions of the act hereby promulgated shall have jurisdiction for all the purposes of said fifth part co-extensive with this kingdom, and said judge or judges shall discharge the duties of the superior and circuit judge contemplated by said fifth part in accordance therewith, and with the forty-seventh chapter of the existing laws not inconsistent with nor repealed by said fifth part.—Said forty-seventh chapter shall, until such passage, serve instead of, and be considered as the act to organize the judiciary department of the Hawaiian Islands alluded to for all purposes not otherwise directed or allowed by the entire act in this resolution promulgated.

7. And be it further resolved, That the general provisions of the act in this resolution set forth shall take effect immediately after the publication hereof, and be also published by one insertion in the Polynesian newspaper, and such other newspaper as the minister of the interior may deem proper.

Done and passed at the Council House, in Honolulu, this 27th day of April, A. D., 1846.
