KOHALA COURT TERM

A CALENDAR THAT WILL CONSUME SOME CONSIDERABLE TIME.

There Are Eighteen Criminal Cases—Ten Native and Eight Foreign—Polygamy—Selling Liquor.

There is a very long calendar to come before the Kohala term. The Hawaiian criminal cases foot up ten in all; foreign criminal, eight; civil case jury, twelve; and about a dozen divorce matters. Besides two polygamy cases the native criminal calendar are as follows:

Republic of Hawaii vs. Hano Panikala, k. and Willie Spencer, forgery. Commitment from District Magistrate South Kohala.

Republic of Hawaii vs. Thomas Martin, k., extortion. Appeal from District Magistrate Kau.

Republic of Hawaii vs. Kekualoa Ahana, w., polygamy. Appeal from District Magistrate Kau.

Republic of Hawaii vs. Elizabeth Mele, w., polygamy. Commitment from District Magistrate North Kohala.

Republic of Hawaii vs. John Halli, k., burglary. Commitment from District Magistrate Kau.

Republic of Hawaii vs. Kane Simeona, k., malicious injury. Appeal from District Court South Kona.

Republic of Hawaii vs. Ah Wa Koi, k., attempt assault. Commitment from District Magistrate North Kohala.

Republic of Hawaii vs. Ichi Toney (Jap.), embezzlement. Commitment from District Magistrate North Kohala.

Republic of Hawaii vs. Akina (ch), selling spiritous liquor without license. Appeal from District Magistrate South Kona.

Republic of Hawaii vs. Apa (ch); selling spiritous liquor without a license. Appeal from District Magistrate North Kona.

Republic of Hawaii vs. Ako (ch); selling spiritous liquor without a license. Appeal from District Magistrate North Kona.




