The Deadlock In Illinois

ILLINOIS REPUBLICANS UNANIMOUS IN SELECTING ITS DELEGATES AT LARGE TO THE NATIONAL CONVENTION BUT HOPELESSLY DIVIDED IN THEIR CHOICE FOR GOVERNOR—THE LEADING CANDIDATES.

SPRINGFIELD, (Ill.), May 13—After sitting for more than twelve hours and taking fifteen ballots in which none of the seven aspirants gained or lost materially, the Illinois Republican Convention adjourned late tonight without nominating a man for Governor.

Two attempted stampedes and several conferences failing to break the deadlock, the candidates for gubernatorial nomination, at the suggestion of Chairman Cannon, agreed to rest on their arms until 10 o'clock tomorrow morning.

While the balloting went forward the party leaders tried in fruitless efforts to get a compromise, but all of their efforts went for naught and there is nothing in the situation tonight to warrant the prediction of a break tomorrow. The convention was large and turbulent. Armory Hall was packed with 10,000 persons during the session and at times when scenes were most turbulent, Chairman Cannon threatened good-naturedly to adjourn the convention to the State Capitol and exclude the public.

Organization of the convention was effected without difficulty. Yates and Lowden were in control and the opposition decided to make no fight against the seating of Yates and Lowden delegates. There was no discussion over the platform.

The wild scenes which characterized the convention last night were repeated again today. A daring young Yates adherent climbed one of the stringers of the convention hall and from his perilous position suspended a portrait of the Governor. Immediately a follower of Deneen duplicated the performance with half a dozen pictures, while Warner and Hamlin men, even more daring, carried great canvas banners to other points of vantage above the heads of the delegates.

Speaker Cannon called the convention to order with a great megaphone, through which he announced that unless order was maintained he would adjourn the meeting to the Hall of Representatives and exclude all except the delegates and representatives of the press. Judge Elbridge Haney, chairman of the committee on credentials, presented a report recommending that the sitting delegates be declared the delegates of the convention. This was adopted, and then, on recommendation of the committee on organization, the temporary organization was made permanent.

The committee on delegates to the National Convention reported as follows:

Delegates at large—Senators Shelby M. Cullom and Albert J. Hopkins, Speaker Joseph G. Cannon and Governor Richard Yates.

Alternates—Lieutenant-Governor W. A. Northcutt, Asa Mathews, Paul Morton and Samuel Inshull.

Electors at large—Lot Brown and William J. Moxley.

This report was adopted unanimously, and the committee on resolutions then reported.

The vote on the adoption of the report was unanimous.

Candidates for Governor were named as follows: Frank O. Loudon, Charles S. Deneen, Howland J. Hamlin, Vespasian Warner, Richard Yates and L. Y. Sherman.

No nomination for Governor had been made up to the fifth ballot, which stood: Yates 491, Loudon 408 11-66, Deneen 380 5-66, John Pierce of Kewanee 21 35-66. Pierce was placed in nomination after the second ballot had been taken.

On the seventh ballot the Adams county delegation undertook to start a Yates stampede, but Cannon suppressed the demonstration by vigorous use of the gravel, and the ballot resulted in practically no change.

On the ninth ballot the bolters in the Alexander delegation returned to Yates, and the Yates people started another demonstration, which they repeated when Boone county gave their candidate three votes. The roll-call, however, was without material change.

The tenth, eleventh, twelfth, thirteenth and fourteenth ballots were indecisive.

The fifteenth ballot resulted: Yates 496, Lowden 405 3-22, Deneen 361 9-22, Hamlin 117, Warner 36, Sherman 51, Pierce 61.

At 10:28 p. m. the convention took a recess until 10 a. m. tomorrow.

Of the three leading candidates, Richard Yates, is the present governor, and is a son of the Richard Yates who was "war governor" of Illinois during the civil war, and who was at that time the idol of the Republicans of the state.

Frank O. Loudon is a son-in-law of the late George M. Pullman, the sleeping-car magnate. He came to Chicago from Iowa and began the practice of law. He married Pullman's daughter, was one of the executors of Pullman's will, and for several years has been quite a figure in Illinois politics.

Charles S. Deneen is the States Attorney of Cook County serving his second or third term. His duties are to conduct all criminal trials on behalf of the people. He has been influential in Cook County Republican politics for several years.

MILES PRAISES THE JAPANESE

GENERAL SAYS THEIR SUCCESS IS DUE TO THEIR WONDERFUL SKILL AND REMARKABLE ENTERPRISE—ADMIRAL DEWEY DECLARES THAT AMERICA HAS BEST SHIPS, OFFICERS AND MEN IN THE WORLD.

NEW YORK, May 13.—"The Russian soldier is courageous in saying his prayers before going into battle, and the same thing may be said of the soldiers of the Sultan, but I have found that on the battlefield it is the fighting and not the praying that wins," said General Nelson A. Miles tonight in explaining the success of Japanese soldiers against Russia. General Miles was speaking at a dinner to members of the order of the founders and patriots of America, of which Admiral Dewey today was elected Governor-General.

"It has been my privilege," said General Miles, "to see most of the armies of the world. I have studied carefully the armies of Japan and of China, and the soldiers of Russia, and the success in the East today of the soldiers of the Mikado is due to their wonderful skill, the faithful performance of their duties and their remarkable enterprise.

"Of all the armies of the world," continued General Miles, "ours seems to differ in that the men are serving for principle. Our men seem to feel that they are working for a free people, for a republic, in which every man is a sovereign and every woman a superior of a sovereign. Our flag represents the sovereignty and the freedom of manhood. It is a pleasure as well as an honor to serve under it. I know this from my forty years' experience as a soldier. In all that time there never was an hour of the day that it was not a pleasure to me to be in the service."

Admiral Dewey said: "I do not know as we have any better navy than we had, but we have better tools than we had a few years ago. Of course, the newspapers will say we have not, but, take my word for it we have the best ships and the best officers and the best men in the world. As to the enlisted men especially, we are getting the cream of the world, and with such men ready and eager to fight, the other nations are going to let us alone. And in a few years to come, the American people are going to have the very best navy in the world, not for aggression, but to protect our rights."

Democratic Primaries and Convention.

A Democratic Convention for the Territory of Hawaii is hereby called to meet in the City of Honolulu on the 6th day of June 1904, for the purpose of electing six delegates and six alternate delegates to the National Democratic convention to be held in the city of St. Louis in the state of Missouri, July 6, 1904.

The Convention hereby called shall consist of delegates elected at primaries to be held between the hours of 2 and 8 p. m. Saturday May 8, 1904, in the several precincts of this Territory. Such primaries shall be conducted by the precinct clubs of the respective precincts, organized under the authority of the Democratic Territorial Central Committee. The executive committee of each precinct club shall provide and appoint a suitable place for holding its primary and appoint the necessary officers to conduct it.

At such primaries none but members of the precinct club shall be entitled to vote. Each precinct club shall be entitled to one delegate to the Territorial Convention for each ten members; but each precinct in which there is a regularly organized precinct club shall be entitled to at least one delegate.

The club membership hereby made the basis of representation in the territorial convention shall be the membership as it exists at the hour of opening the primary.

Democrats throughout the Territory are urged to organize. A provisional district committee has been appointed for each of the other islands to whom inquiries may be addressed.
