ISLAND RICE ON THE COAST

MARKET THERE IS DEMORALIZED BY INDISCRIMINATE OFFERS AT PRICES FOR \$2.50 TO \$2.75.

Williams Dimond & Company give the following important information regarding the rice market in their latest market circular. With the last 24 hours the market South for Japan seed rice has advanced 1-4 to 3-8 cts, owing to the favorable report of Cuban Senate committee this refers to the Cuban Senate not the U. S.) allowing rice from America to enter Cuba under favorable terms. The ultimate result of this matter is of course uncertain, but looks well for the southern rice interests as there can be no possible opposition from any of the northern states rice growing being virtually confined to Louisiana and Texas. Imported Japan rice 4.40 cts duty paid. Island rice. The market for this rice is very badly cut up and prices depend entirely on grade. That portion raised in the islands from China seed is selling here at 4.25; the balance from 2.75 to 2 cents. In this connection some Honolulu firms are offering rice to arrive indiscriminately at 2.50 to 2.75 f.o.b. Honolulu. A strong selling arrangement through one channel would materially aid in disposing of island rice.

HOUSE CUTS AN ITEM ONE CENT

THE DEFICIENCY APPROPRIATION BILL RETURNED TO THE SENATE THIS MORNING.

The Senate began business this morning with the current expense bill and the governor's message containing the list of appointments to fill vacancies in the list of election inspectors before them. When the session opened the House returned Senate Bill 6, the deficiency appropriation bill, amended so as to add about \$4,000 to the amount carried in the measure as it passed in the Senate, and cutting out one cent by reducing the appropriation to blind Prof. Koehse's note books from \$3.16 to \$3.15. The bill, as it passed the Senate, appropriated \$10,221.33. The Senate failed to concur in the House amendments, and the bill was sent to the Ways and Means Committee as a conference committee. House Joint Resolution 2, providing for the building of certain roads and bridges, passed first reading and will be read for the second time on Monday. Senate Bill 5, appropriating \$3000 to pay expenses of witnesses in criminal cases, a deficiency bill, passed second reading and will be read for the third time on Monday. The Senate then took up House bill 4, the Current Expense Bill, for third reading. The bill was read through without change, but at the conclusion of the reading Lane again made his motion to insert the item of \$3000 to pay the attorneys for the defense of the County Act. Wood seconded the motion. Dowsett made an explanation in which he said that he understood the

Glorious Battle Of The Taro Patch Fought This Morning

KU-I A GIGANTIC NATIVE FISHERMAN COMBINING BRUTE FORCE WITH SOAPY STRATEGY ELUDED CAPTURE BY A POSSE OF POLICE—DESPERATE EXCITING STRUGGLES IN MUD AND SLIME OF PALAMA.

John Ku-i a gigantic Hawaiian fisherman, nearly disrupted part of the police force this morning and incidentally gave an entire police posse a mud bath. Ku-i was crazy the officers claimed. From the way he acted today he must have been the Wild Man from Borneo.

Early this morning word was received at the police station by Clerk Baker

that a crazy man was running around in Palama back of the pumping station close to the residence of Representative Mabelona. Lieutenant of Police Hart accompanied by Officers Nelson and Kullike went to arrest the man. The police were warned that the crazy man was a strapping man and might make

DEADLOCK, IN TEST CASE

HIGHTON CONFERENCE WITH GOVERNOR CARTER—A DISAGREEMENT OVER MANNER OF PROCEDURE THAT MIGHT RESULT IN WITHDRAWAL OF COUNSEL—HENRY E. COOPER EXPLAINS THE POSITION OF COUNSEL FOR THE DEFENCE.

The proposed county act litigation is still unsettled as to the manner of procedure. Practically no progress has been made, the attorneys being unable to agree on how to proceed. In fact there is a sort of a deadlock. Judge Highton and, incidentally Governor Carter, being anxious to have an agreed submission in the Supreme court with a view to saving time and expense, and Judge Cooper and T. McCants Stewart having reached the conclusion that the case ought to be fought from the first, through the circuit court.

Yesterday afternoon Highton had a lengthy conference with Governor Carter. He explained his position in the matter, stating that he was not responsible for the delay, but that he had been unable to proceed in the Supreme Court because the other side would not agree upon a statement of facts and issues. With such agreements made, Highton said he was prepared to go ahead.

The governor this morning said that

THE DAY TO VOTE

REPUBLICANS HAVING THEIR PRIMARY CONTEST, TO CHOOSE DELEGATES TO THE COUNTY CONVENTION—BROWN-CRABBE CONTEST THE ONLY ONE STRENUOUSLY WAGED—PROBABLE CANDIDATES FOR THE VARIOUS OFFICES.

The day of the Republican primaries has arrived and finds only one real contest for nominations. That is the one between A. M. Brown and Clarence L. Crabbe for the nomination for sheriff. There is a lot of active work being done in this fight, and it will impart life to the primaries up to the last moment. According to very general opinion among the politicians the Brown strength has markedly increased during the past week, while administration support of Crabbe is far less in evidence. Sam Johnson's open announcement in the Fourth that he was not supporting Crabbe was a marked sign of weakness. For Johnson has considerable power in the Fourth. But neither is Johnson supporting Brown, and there is talk of a dark horse to be sprung on the convention.

For the other offices there is no

change. E. A. Douthitt seems fairly sure of the nomination for county attorney. For auditor the only man mentioned among the politicians, in fact the only one who has been at all announced as a candidate, is Mahelona. His chance of a nomination, however is not regarded as very strong. R. W. Shingle and C. W. Booth may oppose one another in the convention for treasurer, but their respective supporters are doing little work today. For county clerk, Kalauokalani and Pihonala, clerk and assistant clerk of the House, are mentioned. Senator Achi is among those most mentioned for supervisor at large, the senator having decided that he may legally run for the office in spite of his being a senator. Whether the convention will agree to this, in

THE SALARY BILL NOW IN THE HOUSE

COMES FROM THE SENATE, IS ORDERED PRINTED—HOUSE GOES INTO COMMITTEE OF WHOLE.

The House of Representatives this morning received Senate Bill No. 2 from the upper house, the salary bill for which so many people have been anxiously watching. It was read by title for the first time and was referred directly to the Printing Committee.

The order of the day was reached immediately after the formalities and the House went into Committee of the Whole on Senate Bill 2, regarding special appropriations.

Nakulua, who is chairman of the Committee, was not in his place and rumor had it that he was in consultation with the Governor, so a temporary recess was taken until the representative from Molokai could escape from the robin's-egg-blue.

The chairman having appeared the committee went into session. Nothing was done with reference to Holstein's motion of yesterday to refer the Maui items back and Kauai's appropriations were taken up with the following results:

He is forty-five years old and was for many years principal private secretary to the late Marquis of Salisbury, who, on his retirement, appointed him Secretary to the Public Works Commission, a post worth \$7,500 a year.
