## FREAR'S SECRETARY IN AUTO ACCIDENT

FREAR'S SECRETARY RAN DOWN AND INJURED A PORTUGUESE WHILE DRIVING AUTOMOBILE ON THE STREET THIS AFTERNOON—THE INJURED MAN GOES AFTER A WARRANT AS SOON AS HE IS ABLE TO DO SO.

C. H. McBryde, lately appointed private secretary to Governor Frear, shortly after 1 o'clock this afternoon ran down with his automobile a street sweeper named Philip Da Cambra, injuring the man severely, but probably not dangerously.

## QUEEN'S ANSWER WAS NO

THE WEIRD WAIL OF TAHITI—PRINCE WHO STARTED MARRIAGE YARN.

After printing on Sunday a full page tale about Prince Saliman of Tahiti's prospective marriage with Queen Liliuokalani, illustrated with photos and colors, the San Francisco Call last week got "the right dope," and straightened matters out with the following pathetic story:

"Prince Saliman of Tahiti is in torture. Queen Lil of Hawaii has declined the honor of being Mrs. Prince Saliman and the disappointed suitor has the gout. Borne down by the double affliction the scion of South sea royalty, who came to San Francisco weeks ago on his way to Honolulu to become the prince consort of the deposed queen, remains here in the depths of woe, unwilling to return home without a wife and uncertain of the wisdom of continuing his journey to try the efficacy of a personal appeal in offsetting the flat refusal he received yesterday by cable.

"This declination was couched in the single, snuffy word "No," and Queen Lil had not the grace to cable it herself. It was signed by her secretary.

Saliman is terribly cast down. He does not know what to make of the court dismissal and he is thinking of sending home to Tahiti and have his family forward letters which he says would be convincing proof in a breach of promise suit. Not that he is going to institute such a vulgar proceeding. No; Saliman loves Queen Lil, and he merely intends to use them to refresh the memory of his dusky royal sweetheart and remind her that once she was not so cold and heartless.

"My heart is nearly broken," said Saliman last night, drawing a smooth, pudgy hand from right to left over the vast expanse of negligee shirt front covering the upper portion of his 329 pound body. He was sitting in his apartment at the Imperial and was on the verge of weeping.

"When I arrived in San Francisco to take ship for Honolulu I was as light as a bird; now I am as heavy as lead," Saliman continued plaintively. "Queen Liliuokalani had been urging me to come to Hawaii and led me to believe my suit would not be in vain. On my arrival here I sent her a message by cable, saying I was ready to embark on my journey to her and spending the happy day on which I could claim her hand."

"No answer came to that message. I was frantic. I sent another and another. Every day I paid cable tolls. No answer until this one—this heart-breaking "No!"

And Saliman, rising wearily upon his gouty legs—both nearly as big as barrels—crumpled up the cable form

## FREAR ON WALLACH

EXECUTIVE SENDS REPLY TO PETITION OF HOME RULE PARTY THAT "MR. WALLACH BE GIVEN LEPPERS FROM MOLOKAI TO TREAT—PROPOSITION ILLEGAL AND NOT TO BE APPROVED EVEN IF LEGAL.

Governor Frear today addressed a letter to President Notley of the Home Rule party, answering the petition of members of that party regarding Wallach. The letter is as follows.

Executive Chamber  
Honolulu, Hawaii, Oct. 8, 1907  
"Mr. Charles Notley, President, Independent Home Rule Party, Honolulu, Hawaii.

"Sir: I have examined the petition and accompanying exhibits presented to me a few days ago by you and Mr. William White representing the executive committee of the Independent Home Rule Party on behalf of Mr. J. Lor Wallach, and have given these and also the statements made by you

and Mr. Wallach on that occasion due consideration.

"The request is that Mr. Wallach be permitted to select and treat lepers under the conditions set forth in his statement attached to the petition. The conditions set forth in the statement and explained to some extent orally are, in general, that a committee of twenty laymen be selected, subject to Mr. Wallach's approval, to go with him to the Leper Settlement to select fifteen lepers to be brought to Oahu; there to be subject to his sole supervision and treatment for six months at a place provided by him and at his

## Suit to Condemn Mahuka Site Title

According to advices received from Washington today, a condemnation suit is about to be brought by the Federal government, to secure the Mahuka site property for a Federal building. The title offered has been found defective, as The Star stated some time ago it would be, and the government wants a clear title in the form of a decree of court that will forever shut out all claims.

The decision to go ahead and sue, means that there is no longer any question of the finality of the selection of the Mahuka site. The proceeding will be brought in the United States District Court. It is expected, though District Attorney Breckons, when telephoned to for information as to such a suit, said he had no information on the subject.

The defects in the existing title are understood to be largely in the matter of boundaries. The history of the various transfers of sections of the property brings out many different boundaries, hence the owners of all adjoining property will be made defendants, including the Territory, which has stated lines to defend.

It is not thought that there will be any contest over the matter, as adjoining property owners are believed to be ready to accept the boundary lines as set forth in the rejected record title of the owners of the site. As in the cases of Pearl Harbor and Wai-kiki lands, the government wants a court decree.

It is said that outside of the Land Court titles granted within the past few years and other court titles, there are few if any record titles to real estate in Hawaii, which would satisfy the federal requirements.

## AN IMPORTANT LAND DECISION

Judge Weaver of the Land Registration Court rendered a decision this morning in the matter of the application of W. R. Castle, trustee for T. F. Lansing, for title registration to certain lands on the other side of the islands, in which the registration prayed for is refused without prejudice and with permission to amend petition in conformity with the decree.

The Court holds that the petitioner is not entitled to registration either as to boundaries or to all the land included in the petition.

In this case two kuleanas claimed by Margaret Cullen within the boundaries described in the petition, the Court holds that although the location is a matter of doubt, the petitioner cannot claim such kuleanas by adverse possession because their grant from the government was not made until

(Associated Press Cable to The Star.) KINGSTON, October 8.—President Alexis of Hayti is seriously ill.

## OVER TWO MILLIONS

FINE PACIFIC MAIL AND SOUTHERN PACIFIC MAY GET OVER MONGOLIA CARGO.

SAN FRANCISCO, September 28.—The Federal Grand Jury reported to Judge De Haven late yesterday afternoon the finding of five indictments against the Pacific Mail Steamship Company and the Southern Pacific Company for violating the interstate commerce law by shipping to Eastern importers a large cargo of matting at a lower rate than that specified by law. There were two indictments of eight counts each found against the steamships company and three indictments, aggregating 108 counts, against the railroad company. Two of the latter indictments were of fifty counts each and one indictment for eight counts.

There were no individuals mentioned in the indictments, which were found against the corporation alone. Assistant District Attorney Clark appeared before the Court and asked that

## COLLEGE'S PROGRESS

OAHU ADDS SIX NEW TEACHERS TO HANDLE INCREASED ATTENDANCE.

President A. F. Griffiths of Oahu College has submitted to the trustees a report for 1906-1907 showing attendance at the college, and plans for handling the steady increase in number of pupils. The report shows that the present year, with an enrollment of 598 students, is the biggest yet. There were 501 last year, and the report gives tables showing as far back as 1900, when the number was 45. In comment on the tables Professor Griffiths says:

"This shows not only the largest registration yet recorded but also an attendance that has taxed our capacity. Two other conditions which do not appear in this summary are perhaps worthy of comment. One is the increase in the percentage of white stock, and the other is the large number of children who are leaving the Islands permanently. As far as we can ascertain with any certainty, 34
