FREAKS OF THE CHOLERA

(Continued from page one.)

word was said about cholera restrictions, so they took the berths offered. When they got here this morning they discovered that they would not be permitted to go ashore, because they were second-class passengers. Only the cabin passengers, and five of the ship's officers, who had urgent business ashore, would be permitted to leave the ship, they were told.

Steerage Passenger Ashore.
That was pretty bad, but it seemed to be worse when they found that engineers were going ashore, and then a second-class passenger, a servant to one of the first-class travelers, was permitted to land, and then a steerage passenger went ashore, just because he was the servant of a first-class passenger.

"To think," said Mr. Donnelly, "that we, American citizens, are restricted from going ashore at an American port, when two aliens, one in the second-class, the same as we are, and the other in the steerage, can leave the boat. One of those men is an Indian, a British subject."

"I made a kick to the doctor, but he said that he could not do anything. In my opinion, I think he used pretty poor judgment in passing this ship.

We were never told that we would have to be subjected to such indignities because we were forced to travel second-class, as there was no accommodation in the first-class. They are packing them in there now, and we had no possible chance of getting a berth. We would not get into any worse places than the first-class passengers, and I'll bet I've got as much money as some of those ginnies, any way.

Says it is Rotten.

"You can just make a kick for me as hot as you like. I think it's rotten the way they treat the people here over this quarantine regulation. Take those Filipinos that you are importing here. They come from the worst cholera districts, and you let them ashore to mingle with your people here. Here we are, we've been in Manila, and have never been ill, and you won't allow us ashore. I think it's a shame, and we all ought to walk ashore. I don't think they could stop us."

The Logan in Quarantine.

The Logan, arriving yesterday from Manila, was carefully guarded as far as everyone but cabin passengers were concerned, and no one from ashore, except various doctors, customs men, and persons having some special business was allowed up the gangway. The cabin passengers all came ashore and went wherever they chose in cholera-infected Honolulu, and then returned to the ship.
