January Term, 1881.
Harris C. J., Judd and McCully, J. J.
Andrew Welch vs Thomas Spencer. In Banco.
Opinion of the Court by Judd, J.

At the January Term of this Court, 1881, the
plaintiff Andrew Welch, who is a commission
merchant in San Francisco, doing business as
Welch & Co., brought his action against the
defendant Thomas Spencer, who is a sugar plan-
ter of Hilo, Hawaii, to recover the sum of
nineteen thousand eight hundred dollars, being
the amount of principal and interest on two
promissory notes, for five thousand dollars,
dated at Hilo, October 1st, 1872, payable one in
sixteen months, and the other in two years, with
interest at one per cent. per month, to the order
of Messrs. Walker & Allen, and expressed to be
for indebtedness to a mortgage dated July
1st 1871, given by the defendant to the plaintiff,
and secured by Messrs. Walker & Allen. The notes
were secured by an assignment by them of the
mortgage referred to, to the plaintiff. The
defendant pleaded the general issue and the
statute of limitation.

To this, the plaintiff filed a replication,

defendant had paid to the plaintiff on account of
the notes, various sums amounting to \$3,141.41,
