A Mean Assault.

One of the Greeley organs in this city, apparently anxious to make itself as contemptible as possible in the eyes of all the honest people of the State, assails Tom Osborn, the Republican candidate for governor of Kansas, with a half-column of the meanest and lowliest slanders, from which we have been obliged to withhold our name.
