COMMERCIAL LAW.

Refers to the Commercial Law, as it applies to the business of the day.

When a person deals with another as a principal, he is liable for the acts of his agent, even if the agent is not authorized to do the act.

The body of a promissory note reads: "I, the undersigned, do hereby promise to pay to the order of the payee the sum of \$100.00 on demand."

A carrier is not responsible for accidents which could have been avoided by the highest degree of care, such as, for instance, as result from defective machinery, or other similar causes.

Where a party is liable for an act which is not a tort, but which is a breach of a contract, the party is liable for the act.

The rule of estoppel is that a party who has made a statement of fact, and who has acted upon it, is estopped from denying the truth of the statement.

A law of the State of Missouri, which provides that a person who is liable for a tort, shall be liable for the same, is not unconstitutional.

When real estate is sold to be fully paid for by a vendee, the vendee is not liable for the taxes on the property.
