These fine vessels were examined as to their strength for carrying guns and capabilities as war steamers, in the event of their being required by the Government.

It is stated that the Admiralty have been for some time in possession of sufficient information to be able to arm them, and the General Steam Navigation Company's vessels, on the whole, are the best adapted for the purpose.

The prices at the Danube are 20s 6d per quarter, on board, and 19s 6d per quarter, landed. The price of wheat is 1s 2d per bushel, and of barley 1s 1d per bushel.

Recent accounts from Hamburg state that a material improvement had taken place in the grain trade from the 21st ult., and that several thousand quarters of wheat had changed hands at enhanced rates.

By the latest advices from the Mediterranean, we learn that the dull reports from England had an influence on prices in that quarter, at the same time, the price of wheat was 1s 2d per bushel, and of barley 1s 1d per bushel.
