EMPEROR FREDERICK.

His Ailment Thought To Be Approaching a Crisis—New Phases of the Disease.

BERLIN, June 11.—The National Zeitung says: "The insertion of the canula in the Emperor's throat causes difficulty because the trachea has become so enlarged that the tube no longer fills it completely, and the pus coming from the upper part can thus flow into the air tubes. To prevent this a rubber ring has been fitted on the canula so as to fill the space between the tube and the wall of the trachea. In order to remedy the dryness of the throat arising from the difficulty in swallowing, the Emperor takes frequent sips, day and night, of lukewarm milk and whisky."

LONDON, June 11.—The St. James Gazette's Berlin correspondent takes a decidedly pessimistic view of the condition of the German Emperor. "Wide circulation, he says, has been given to rumors circulated during the last week that his Majesty was rapidly failing, and evidence of the truth of these rumors has been abundant from unusual and unlooked-for sources. There is little doubt, the correspondent believes, that a crisis is near at hand, growing out of fresh complications in the disease, with the doctors are unable to cope, and in some cases do not understand. The official bulletins fail to make clear in their ostensible explanations the necessity for the new and extremely complicated canula which was inserted in the Emperor's throat today, and the inference is that the Emperor's disease has developed phases entirely beyond the ability of the doctors to command or remedy by old means."

The Emperor's difficulty in swallowing continues and increases, though his condition was slightly improved this evening. Dr. Howell has returned to duty at his Majesty's bedside.

ENGLAND'S BUGBEAR.

Lord George Hamilton Furnishes a Few Figures on the Invasion Question.

LONDON, June 11.—In the House of Commons, today, Lord George Hamilton, First Lord of the Admiralty, stated that the calculation made in regard to the number of transports necessary to enable 100,000 men to land in England, and to seize London by surprise, took into consideration only the condition that such a feat was possible, that the whole army could disembark simultaneously and when landed that it would be capable of rapid movement. The estimate that ships with a gross tonnage of 480,000 would be required for the transportation of the invading force, he said, was the assumption that it would be equal to three army corps comprising cavalry and artillery.

Mr. Childers asked, seeing the interest which the subject was exciting, that a detailed and authoritative statement be presented to Parliament.

Mr. Hanbury asked whether the naval and military departments had consulted on the subject.

Lord George Hamilton replied that data had been obtained thirteen years ago as the result of a joint conference, and promised to produce those of the transport department, which satisfied him that the estimates were not over-optimistic.

Such an invading force from the continent, he continued, implied the presence of a fleet of 200 battleships, 100 cruisers, 100 torpedo boats, and 100 minesweepers, with a successful voyage of not less than a week, instead of a few hours, and made without opposition from a hostile fleet.

GENERAL FOREIGN NEWS.

Statement of the Cause of the Quarrel Between Italy and Zanzibar.

ROME, June 11.—In the Chamber of Deputies today, the government made a statement in reference to the differences between Italy and Zanzibar. The late Sultan, it appears, ceded territory to the Italian Commercial Company, but the cession was subsequently partly revoked.

The present Sultan, on succeeding to the throne, wrote to King Humbert, who replied that he would not recognize the cession of King Humbert's territory, upon receipt of which the Italian government had taken the cession as a matter of course.

The consul was compelled to haul down the flag and delay in order to avoid anything like pressure on the satisfaction take the form of a cession of territory to Italy. He adds that the presence in Zanzibar of representatives of powers friendly to Italy is a greater reason why she should obtain the satisfaction than the fact that Italy shall have been satisfied she will be able to examine other matters in dispute between the two countries, notably the question in regard to the territory which was ceded by the late Sultan.

A KANSAS WAR.

Serious State of Affairs in Stevens County, Caused by a Railway-Bond Election.

TOPEKA, June 11.—A telegram was received today by Governor Martin, from Brigadier-general Murray informing him of the alarming state of affairs that exists in Stevens county, on the frontier, caused by a railway-bond election. The towns of Wooddale and Hugoton are located about two miles apart, and a bitter feeling has always existed, growing out of a county-seat fight. The telegram gives details of a shooting which occurred in Hugoton. R. L. Jones, the deputy sheriff, who is a Wooddale man, the constable of Wooddale township, and another officer, rode into Hugoton and attempted to assassinate Sam Robinson, the chairman of the board of county commissioners. They pretended to have warrants for the arrest of the parties, but instead of serving the warrants by the sheriff, they opened fire upon the marshal and the chairman of the board. The fire was returned and the attacking party retreated. One man was seriously wounded, and the murderer secured the teeth, and bloodshed may follow.

Horribly Tortured by Thieves.

PITTSBURG, June 11.—An atrocious outrage is reported from Fair Chance, about two miles from Uniontown, Indiana. A farmer, an old resident of Fair Chance, was assaulted by masked men at his residence, at midnight, Saturday, and subjected to great tortures to make him disclose the whereabouts of his money. At about four o'clock, a man named John Lambert, who lives alone, was aroused by a knock at his door. In response to his inquiries as to who was there the men outside asked for the money, and Lambert refused to open the door to comply with their request. He was seized and gagged. Two ruffians then searched the house but failed to find anything of value, whereupon they commanded their accomplice to surrender his money and valuables. He insisted that he had no money. The two fiends then built a fire in the grate and, drawing the man up to it, roasted his feet and hands. He was blistered and shockingly burned. Still the old man protested that he had no money, and implored them to release him. They threatened to kill him if he did not surrender. After turning everything in the house upside down and ripping up the carpet in their search for money, they bound the old man hand and foot, and departed after a desperate struggle, freed himself and gave the alarm. His neighbors quickly gathered and organized a search party to hunt the rascals down. The fugitives fled in the direction of the hills, and have, it is said, been located. The community is greatly excited over the outrage, and the ruffians are found the chances are that they will be treated to a dose of Western justice.

Twenty-Three Days of Fasting.

RAVER, Wis., June 11.—John Zacher, Jr., son of a wealthy Bohemian farmer living in Pleasant township, north, has not tasted food for twenty-three days. During the greater portion of that time he has done arduous farm work, but has not had time to eat. He is more laborious than light chores exhaust him. He talks rationally and gives no other reason for his abstinence than that he is not hungry. Two doctors have been called to examine him, but their efforts to induce him to take food have so far proved unavailing. It is thought his self-imposed fast is a pronounced symptom of insanity, although the indications in his case are not clear. Insanity has run in the family for several generations. Zacher is fully six feet in height, and has been a very powerful man. His clothes are in a state of decay, and he has shrunk away to a marked degree. The doctors do not think he can live long.

Hanged by a Mob.

EVANSVILLE, Ind., June 11.—At Henderson, Ky., twelve miles below here, at 1 o'clock this morning, James Foster, colored, was taken from a mob and hanged to a tree. Foster was being arrested, strangled, denied his guilt, but the most conclusive evidence of it was found. As the quiet little city was asleep at midnight, 200 Kentuckians, mounted on horseback and armed to the teeth, rode into the distance, rode into the city. Pulling up at the jail, they made a break for the iron doors, and before the jailer was fully aroused, they were dragging the prisoner to the scene of his crime and hung him.

Knights of Pythias.

Why Mr. Walsh Left France.

McKenna, of the Chicago Clan-na-Gael, was on the same steamer. While in France, Walsh was shadowed by English detectives, who discovered the details of the supposed plot. Walsh, it is said, admitted to the Secretary of the Republican party, Mr. Harrison, a scheme, and that was the cause of his leaving France.

The Cincinnati Liquor Prosecutions.

CINCINNATI, June 11.—More than one hundred and fifty warrants were served today upon saloon-keepers for selling liquor yesterday. So far the issuing of warrants and the giving of bonds are the only forms of punishment inflicted for the violations of the law. Five trials have been had, with one conviction, two acquittals, and two disbursements of the jury. The conviction was accompanied by a fine of \$100. There is talk of abandoning all effort to prosecute, as it is found that where so testimony in defense is offered, and where the testimony for the State is clear and unimpeachable, the jurors refuse to render a verdict of guilty. There is a proposition to take the case to the Common Pleas Court, where a different system prevails for selecting juries.

Upon arrival they were escorted to the headquarters on Walnut street, where an entire business block is fitted up as a reception and dining-hall. After feeding the hungry, they are assigned to permanent quarters for the meeting. The great parade, which is expected to eclipse every thing of the kind heretofore accomplished, is set for Wednesday afternoon, and will start from the city hall at 10 o'clock. The twenty-five-foot standard in front of the government building, extending from Walnut to Main, with an immense reviewing stand, from which the Republican and other dignitaries will review the procession.

Why Mr. Walsh Left France.

NEW YORK, June 11.—Thomas Walsh, the Irishman who was said to be implicated in a plot which resulted in the murder of Lord Cavendish and Secretary Burk, in Phoenix Park, Dublin, in 1881, arrived in New York today. He came on the La Normandie, of the French line, and the assurance was given by Mr. Walters. He was met by several well-known Irish nationalists and was driven to the Hotel Albert. F. W. McKenna, of the Chicago Clan-na-Gael, was on the same steamer. While in France, Walsh was shadowed by English detectives, who discovered the details of the supposed plot. Walsh, it is said, admitted to the Secretary of the Republican party, Mr. Harrison, a scheme, and that was the cause of his leaving France.

The Cincinnati Liquor Prosecutions.

CINCINNATI, June 11.—More than one hundred and fifty warrants were served today upon saloon-keepers for selling liquor yesterday. So far the issuing of warrants and the giving of bonds are the only forms of punishment inflicted for the violations of the law. Five trials have been had, with one conviction, two acquittals, and two disbursements of the jury. The conviction was accompanied by a fine of \$100. There is talk of abandoning all effort to prosecute, as it is found that where so testimony in defense is offered, and where the testimony for the State is clear and unimpeachable, the jurors refuse to render a verdict of guilty. There is a proposition to take the case to the Common Pleas Court, where a different system prevails for selecting juries.

The Service-Pension Question.

CHICAGO, June 11.—C. A. Powers, a Grand Army of the Republic member from Hann, Ind., appeared before the Union Veteran Club to-night to urge the calling of a huge number of old soldiers just before the national Republican convention to urge the insertion in the platform of a plank pledging the party to do its utmost to ward securing the passage of a liberal service-pension bill. Vigorous speeches were made in support of the measure. Five hundred members of the club, and it was unanimously voted not to endorse such resolutions or participate in such a meeting, should one be held.

A KANSAS WAR.

Serious State of Affairs in Stevens County, Caused by a Railway-Bond Election.

TOPEKA, June 11.—A telegram was received today by Governor Martin, from Brigadier-general Murray informing him of the alarming state of affairs that exists in Stevens county, on the frontier, caused by a railway
