He Had Fallen on a Broken Window and Died to Death Without Disclosing His Injury—Chicago & Erie Wreck—Men Drop Dead.

LA PORTE, Sept. 9.—A singular death occurred here last night. Charles Andrew, a Swede, was found in an outbuilding in a supposed intoxicated condition. Having no home he was taken to the jail to sober up.

During the night he died from water, and appeared all right, but this morning he was found dead in his cell. An investigation by the coroner to-day showed that he had died from a cut by a piece of glass which had pierced his lungs. He had fallen on the glass while setting a pane for a business house during the afternoon. He never complained of his injury or informed any one, and what was the cause for his death was exhaustion from internal hemorrhage.
