Evidence That This Was the Token by Which Purchased Ballots Could Be Identified.

A little bit of light was gained yesterday upon the mystery surrounding those thousand or more ballots that were cast for Mayor Sullivan and nobody else, last Tuesday. Everything points to the fact that those were purchased votes, and the distinguishing mark to show that the "goods" were delivered was this act of voting for but one man on the ticket.

"In our precinct," said a well-known Republican, yesterday, "it is a well-known fact that there are just four 'boaters.' The politics of every other man in the precinct is well known. All four of them voted on Tuesday, and by a peculiar coincidence there were three votes for Sullivan alone, and one vote for the ticket headed by the same way, but the fellow had missed the square, and his ballot was thrown out. There were three honest scratches for Sullivan, but the name of the ticket was not on the ticket."
