90° FOR WAGON WHEAT. ACME MILLS, West Washington St. ITALIANS WANT INDEMNITY. Families of the Lynched Sicilians Bring Suits Against the City of New Orleans. NEW ORLEANS, March 8.—A new and unexpected chapter in the history of the Hennessy assassination and the lynching of the Italians that followed has come out. Claims will be filed in the United States Court against the city, this week by the families of the Italians who were never naturalized for damages. The claims will vary from \$20,000 to \$40,000, and the total will amount to between \$150,000 and \$200,000. Not one of the families of those who were naturalized is included in the claim. It is a claim against the city. Judge Samuels, one of the best-known citizens of the State, is beginning the suit. It is brought to prevent prescription. The heirs of the mother of the Italian have a claim against the government already, but it is said that it will be worthless unless suit is brought against the city within one year after the occurrence. The year has almost expired.

DRUGS, Etc. DEBQUEE, Ia., March 8.—The Iowa Iron-works of this city, have undertaken to build a boat on an entirely new plan, the object of which is to navigate the river and the ocean. It will have one bow and two sterns, each of which will have a rudder and screw, so if one is disabled there will remain half the power to make port. She will carry an adjustable center-board, which is the thought, will answer the purpose of a deeper draft. The boat will be three hundred feet long and from thirty to thirty-five feet beam. She will be built entirely of steel and will cost about \$300,000. It is expected that she will carry a cargo in weight equaling about sixty thousand bushels of wheat on five feet of water, which will be remarkable if such results are obtained. The vessel, when finished, will be sent with a cargo to the Amazon. She will then go up the river five hundred miles or more, to the coffee plantations, and take from there direct the products which now have to be transferred half a dozen times before reaching a market.
