WASHINGTON, May 24.—The Cabinet, at its meeting yesterday, seriously considered the advisability of the repeal of the order made by Postmaster-general Wasmaker reading as follows: "A letter carrier will not be removed except for violation of the postal laws and regulations, or for some cause affecting injuriously the efficiency of the service or his integrity as a citizen."

The object of Mr. Bissell in attempting to repeal this order of Postmaster-general Wasmaker is to secure to the postmasters of those offices not now in the classified service full power to make all changes desired before the examinations are held by the Civil-service Commission bringing these offices within the pale of classified service.

WASHINGTON, May 24.—A curious experiment is to be tried in the public schools here, Superintendent Powell and Dr. Harris, of the government Bureau of Education, wish to find by actual experiment whether or not there can be established any certain relation between the physical and mental development of the children in the various grades. They have, accordingly, perfected plans for taking the measurement of twenty thousand of the school children of the Nation's capital according to the celebrated Bertillon method, which in France, where it originated, and in this country heretofore, has been confined almost exclusively to the criminal classes. The director of physical training in the schools will conduct the experiments. When the results of the measurements are tabulated it is believed they will disclose whether there is any definite relation between the physical and mental development of the pupils, and if this relation is satisfactorily established it will be used to advantage in guiding the teachers as to amount of work that may be required of a pupil in many cases preventing overstraining of those whose physical development does not keep pace with their mental, and pointing out the cases where extra work is required of a pupil without fear of injury. These experiments are a new departure, but are in line with the advance modern work, and the teachers of the schools are hopeful that they will lead to valuable results.

The assets of the Elmira Savings Bank continue, and all depositors having less than \$100 are being paid.

ANOTHER CHINESE TEST CASE.

NEW YORK, May 24.—Another test of the Chinese exclusion act was made to-day before Judge Lacombe, in the United States Circuit Court, New York, a gray haired Chinese who has been in the United States for thirty-four years, and who served as a cook on board a gun boat during the civil war, was the victim. Look was brought in by a bill of lading on a Confederate gun. It was represented by Mr. Choate and Maxwell Ewart. The latter asked a certificate and Mr. Choate asked that the bill be nullified. THE CHARGES NOT PROVEN

Methodist Preacher at Brazil Demands a Trial and Overcomes His Enemy.

Bynum Tangled Up in the Elwood Postoffice—Miss Byrkit, of Albany, Elopes with Her New Castle Sweetheart—Other News.

REV. SWITZER ACQUITTED.

Chamberlin's Charges Not Sustained in an All-Night Trial at Brazil.

BRAZIL, Ind., May 24.—It seems, for some cause, that George B. Chamberlin, of Lafayette, editor and proprietor of the Battle Ground Repository, also a member of the Northwestern Indiana Conference of the Methodist Church, has held an enemy against Rev. George W. Switzer, who now is pastor of the M. E. Church of this city. On two occasions he boldly charged him with falsehood, and also preferred other charges against him, claiming in one instance that he secured the confidence of Mrs. Whitehead and then used it against Rev. Pettit, who was sentenced to the northern prison several years ago for poisoning his wife. The allegations were made in strong language, and a copy of the paper sent to each member of the conference. However, these efforts had little effect on the minds of members of that body, as no action was taken at their last meeting on the matter, but instead, the subject of the reproach was given a Brazil church which is among the best in the district. After Mr. Chamberlin became cognizant of what the conference had done, he again assailed Mr. Switzer, stating
