

The Pennsylvania Company Finally Seizes Control of the Toledo, Peoria & Western Railway.

Secures the T. P. & W. Comes officially from Philadelphia that the Pennsylvania company has secured control of the Toledo, Peoria & Western.

The Big Four yesterday secured a contract at St. Louis to forward 500 carloads of grain for export to Cuba.

W. H. McDool and Superintendent Lowell are going over the L. N. A. & C. lines looking after transportation matters.

Mrs. Brefford is expected to be a member of the railroad fame, is maintaining a soup house at New Albany at her own expense.

A. W. Case has assumed the duties of general manager of the Chicago & North Western under the title of superintendent, vice A. L. Mohler.

W. S. Spier, assistant general freight agent of the Lehigh Valley road, has removed his headquarters from Bethlehem, Pa., to Philadelphia.

The resignation of Maj. John W. Green as general manager of the Georgia road has been accepted and Capt. R. Scott has been appointed his successor.

The Louisville, Evansville & St. Louis is building up the yards at Chicago and the Louisville and New Albany drawing their supplies from mines on the line.

The first train to start this year the Chicago, Burlington & Quincy's falling off in gross earnings was \$73,260, while its net profit dropped to \$1,000,000.

The east-bound business out of Chicago is said to now be 40 per cent. lighter than in December last, and the Chicago yard is noticeable in nearly all classes of freight.

Thompson Pennsylvania Company will test the new mail crane, the invention of Dr. A. P. Haas, of New Albany, it works as expected the company will adopt it on their local trains.

The Chicago & Alton, which has been running its shops with half force and but eight hours, has resumed operations, ten hours daily, and is now giving employment to two thousand men.

The Big Four yesterday received the last of fifty freight engines which the company has ordered, making eighty-six new engines received in the present year. The company has ordered 100 more.

F. J. Reed, general passenger agent of the Monon, has been called to the post office of passenger business for the last week in November was \$7,185; total increase in the passenger earnings for the month of November, \$19,872.

The Monon is carrying large shipments of cattle from the West and after fattening, chiefly at the distilleries, they are shipped east in the Chicago & North Western houses. The Monon has enjoyed a monopoly of this business for some time.

Some two years ago the Pittsburg, Cincinnati, Chicago & St. Louis refused to deliver certain freights to Thomas Purcell in Chicago until he paid demurrage charges. In the case this week reached the Cook County Circuit Court, Judge H. J. Horton rendered a decision in favor of the railroad company.
