IT MAY BE DEFEATED

Threats of Democratic Senators Against the Tariff Bill.

Special to the Indianapolis Journal. WASHINGTON, Feb. 23.—For the first time since the ways and means committee completed the Wilson tariff bill the chances are more than good for the final defeat of that measure.

Knowledge of this fact is what has demanded a meeting of the finance committee on Monday morning next. Efforts will be made to harmonize the differences over the free list affecting sugar, coal, iron, wool and one or two articles, but it is believed the meeting will fail to result in any
