MAY ENTER POLITICS

CARPENTERS' BROTHERHOOD TO TAKE UP PERTINENT QUESTIONS.

Governor Matthews Addressed the Convention Yesterday - An Expulsion Case from Detroit Comes Up.

Yesterday morning at 10 o'clock the second biennial convention of the United Brotherhood of Carpenters and Joiners of America was opened in the hall of the House of Representatives at the Statehouse with 117 delegates present.

The central States sent the most delegates. It was expected that 125 delegates would be present, but the general officers hope that more will arrive to-day.

General President Trenor presided, and after the usual routine matter was considered the convention listened to welcome speeches by Henry Gale in behalf of the Indianapolis carpenters, William Prescott for the Typographical Union, and Governor Matthews. The Governor said in part:

"You are especially interested in a place that is suggestive of good and neat work in your line. Indianapolis has long established a reputation as being a city of pretty homes and beautiful houses, therefore I trust that you are interested in her, and I can say in behalf of the people of this city as well as for those of the State that you are welcome to be here and mingle with us. Your profession is a noble one. The best, greatest and wisest man that ever was on earth, Christ, was a carpenter. He builded well in the spiritual world, and I hope you will do likewise in the material world."

The Governor's remarks were vigorously applauded. The response was made by General Secretary McGuire, of Philadelphia.

Good-latured discussions in regard to the length of the sessions and smoking marked the opening of the afternoon session, which was settled by deciding that the sessions could smoke and that the sessions would last eight hours. The interest of the day centered in the consideration of the credentials. The membership of Union No. 4, of St. Louis, entitled it to two delegates, but three presented credentials. A short debate but two were seated. The question of expelling Union No. 10, of Detroit, was started and considered until the session closed at 5:30 o'clock.

The matter will be taken up again until this morning's session, when it will be settled. About a year ago a member was expelled from the union so far, yet I have been told that the member was expelled in a manner that was not in the rules of our organization. The rules are that every member is entitled to a fair consideration and trial before he is expelled, and I am sure if the member was not treated fairly that the union will be thrown out of the convention. The union must understand that the rules of the organization must be observed in every member is entitled to the same consideration, private and officer alike."

In addition President Trenor said that several prominent questions will be considered, among them being independent political action, that of dividing the country into seven districts for the brotherhood and having subcommittees under the present ones, and probably the question of the single tax question. In regard to the latter he said that a great number of the delegates were in favor of it, but he was not positive that it would be openly discussed in the convention.

To-day's session will be marked by the hearing of the reports of the committees on finance, complaints and grievances and revisions of the constitution and by-laws.
