When Durrant was suddenly confronted by George King, the organist, he explained his condition of utter physical and nervous collapse by the statement that he had been overcome by the gas while engaged in repairing electric wires in the attic. Durrant asked King to get him some bromo seltzer. The prosecution will contend that if Durrant had been asphyxiated by gas, he would not have been able to carry out his plan to bring him relief with a drug, but to give himself time to recover from his condition by the use of bromo seltzer.

They assisted at least as many more to get back on the street back of the stand. All the ambulances and patrol wagons in the city were summoned and those only slightly injured were taken to the hotels or to their homes. On the portion of the grand stand which fell there was a scene of horrifying confusion. Mr. Vreeland, assistant city editor of the Courier-Journal, was present when the accident occurred. YACHT RACES ENDED

INGLORIOUS OUTCOME OF THE CONTEST FOR THE AMERICA'S CUP.

Defender Forced to Sail Over the Course Yesterday Because the Englishmen Quit.

LORD DUNRAVEN ANGRY

WITHDREW HIS YACHT BECAUSE HE COULDN'T HAVE HIS OWN WAY.

And Wouldn't Race Even When the New Conditions He Sought to Impose Were Partly Agreed To.

ISELIN'S OFFER REJECTED

HIS LORDSHIP DECLINED TO RESAIL THE PROTESTED RACE.

Statements from the Regatta Committee and Members of the Yacht Club—What the Foreigners Say.

NEW YORK, Sept. 12.—The international series between Defender and Valkyrie for the America's cup is ended. On the whole it has been an extraordinary series, and while the result is satisfactory to the American people, two, at least, of the contestants that went to make up the match were not. Defender won in a clear race Saturday; in the last race she crossed the line behind the English boat, but was awarded the race on a foul; to-day she had a walk-over. Today's occurrence was all the more unfortunate, because a great crowd had gathered to witness the struggle, and because the weather conditions were such as to lead many to suppose that of all days Valkyrie would be in her element.

SCHEME OF WILLY CHINESE.

Trying to Enter This Country on the Plea that They Are Skilled Actors.

SAN FRANCISCO, Sept. 12.—Collector Wise has discovered an ingenious fraud by which shrewd San Francisco speculators in the Chinese traffic are seeking to evade the Geary law and introduce three hundred Chinamen into the United States under the pretense that they are skilled actors and that they are coming to America to give the visitors at the Atlanta exposition an opportunity to see some of the renowned male and female jugglers of Hong Kong. A band of more than two hundred men and thirty-four women have been secured for the purpose. They are headed by "Little Pete" and the notorious Long Nam, who have ingeniously dodged the Geary law by applying for admission into the United States at Ogdensburg, N. Y.
