BRYAN SPEAKS

HE HAS NOT YET DECIDED TO ACCEPT POPULIST NOMINATION.

His Action, He Says, Will Depend on What Conditions Are Attached to the Honor.

HE REGRETS SEWALL'S FATE

AND WILL DO NOTHING UNFAIR TO HIS RUNNING MATE.

Part of the Platform is Satisfactory, but It Contains Some Planks He Cannot Indorse.

SEWALL WILL NOT RESIGN

HIS ATTITUDE NOT CHANGED BY THE ACTION OF POPULISTS.

Gossip About the Telegram from Bryan That Was Suppressed by Chairman Allen.

VIEW OF POPULIST LEADERS

WHAT THEY SAY ABOUT THE ST. LOUIS CONVENTION'S WORK.

Signed Statements from Butler, Allen, Donnelly, "Cyclone" Davis, Patterson, Weaver and Others.

LINCOLN, Neb., July 23.—While the public here in Lincoln has been heartily discussing the likelihood of the acceptance or rejection by Mr. Bryan of the Populist nomination or the rejection of Mr. Sewall, Mr. Bryan put in the day in absolute silence as to his intentions, although the pressure was strong to secure an expression from him.

During the forenoon he received many telegrams from St. Louis friends in relation to the perplexing conditions there arising and quite a number from friends in other parts urging him to stand by his previous telegram declining the nomination unless it carried with it that of Mr. Sewall.

Shortly after noon Mr. Bryan entered a carriage with his law partner, Mr. Talbot, and drove away from the Bryan residence. From that time on until nearly 4 p. m. his whereabouts were shrouded in mystery. All knowledge thereof was denied at his home and inquiry at Democratic headquarters and Mr. Bryan's office was fruitless.

When asked later where he had concealed himself Mr. Bryan replied that he had not suspected that any one might wish to see him. In reference to the action of the St. Louis convention he said:

"When the Populists decided to nominate Vice President first, Senator Jones, chairman of the national Democratic committee, wired me as follows:

"Populists nominate Vice President first if not Sewall what shall I do? Answer quick. I favor your declination in that case.

"I wired as follows: "Hon. James K. Jones, St. Louis: "I entirely agree with you. Withdraw my name if Sewall is not nominated.

"These dispatches were published in this morning's papers and the convention understood my position. In spite of this they have sent me to nominate me. Whether I shall accept the nomination or not will depend entirely on the conditions attached to it. My first desire is to aid in securing the immediate restoration by the West and South. The Populist platform and the Republican platform declares that the bimetallic system should be maintained to secure bimetallicism for ourselves until foreign nations come to our assistance.

We cannot afford to surrender our right to legislate for our people upon every question; and so long as that right is disputed no other question can approach it in importance. I appreciate the desire manifested by the Populists to have me restored, but I do not believe that I can do so without aid of free-silver forces and regret that they do not nominate Mr. Sewall also. He stands squarely upon the Chicago platform and has denuded our cause against greater opposition than we have had to meet in the West and South. The Populist platform is on many questions substantially identical with the Chicago platform, but it goes beyond the Chicago platform and indorses some policies which I do not approve of. All that I can say now is that my action will depend entirely on the conditions attached to the nomination. I shall do nothing which will endanger the success of bimetallicism nor shall I do anything unfair to Mr. Sewall."

"Assuming that the acceptance of the nomination by you would be unfair to Mr. Sewall, how could conditions shape themselves so as to prevent you to accept?"

The question was adroitly evaded by the jocular remark that if all things perplexing were made plain it would be an infringement upon the field of journalistic conjecture. When the question of the seeming inconsistency of putting up two sets of Bryan electors in case he remained the candidate of the Populist party were mentioned Mr. Bryan replied that this was one of the difficulties which time must be trusted to remove.

Mr. Bryan was seemingly as cheerful over the situation as he was when he received information of his first nomination at Chicago.

The Nebraska delegation to the St. Louis silver convention returned this afternoon. They say that a notification committee from that convention will not wait upon Mr. Bryan to approve him of his nomination for the presidency thereby until after he has received his notification from the Democratic convention. Mr. Bryan has indicated his conviction that the visits of notification committees should be made in the order of the nominations. As Mr. Bryan will probably receive the notification from the Democratic committee some time about the middle of August and it is believed that he will be in the East for probably two weeks, this will delay the silver committee notification until near the 1st of September. No intimation has been received as to when the Populists' committee may be expected, but if the order of nominations is maintained it will probably visit Mr. Bryan about the same time.

Sewall Will Sign.

BATH, Me., July 23.—In reply to a question as to his attitude and plans in the new situation caused by the Populist nomination of Bryan and Watson Mr. Sewall said to-night after a pause: "Well, the only statement I have to make in regard
