EMPEROR FRANCIS JOSEPH has conferred high decorations upon several of the Russian officers and ministers of state. He has appointed the Grand Duke Nicholas honorary commander of the Hungarian regiment. This is the first time that the Count Goulochowsky, the Austro-Hungarian foreign minister, who had previously conferred with Count Muraviev, the Russian minister of finance, later his Majesty's ambassador in London, and Count Goulochowsky, Count Muraviev and M. de St. Simeon, together with the Russian ambassadors, will attend a banquet in the winter palace.
