HE TESTIFIED AT LENGTH IN HIS OWN BEHALF. The Case Given to the Jury at 4 O'clock—Grand Jury's Report—Other Court Cases.

The case of Bruce Strode, charged with embezzling \$300 belonging to the Joseph McWilliams Company, of Louisville, Ky., contractors who built the tunnel and power house at the county jail, was placed in the hands of the jury at 4 o'clock yesterday afternoon.

The courtroom was crowded all day yesterday. The testimony was finished at noon and the attorneys for each side were given an hour and half for argument in the afternoon.

Yesterday's evidence was of an unusual character, bringing in, in an unlooked for manner, Councilman John M. Higgins, who is now serving time in the penitentiary for soliciting a bribe for his vote in the Council.

Strode testified that he was arrested by Higgins and taken to the county jail. He said that he was later rearrested and brought back to this city. Strode testified that he was rearrested because he refused to pay Higgins an additional \$30 for going on his bond.

In his testimony yesterday, Strode said he desired to quit work for the company because the company complained that it was not progressing fast enough.

GRAND JURY HEARD FROM. No Evidence Against Dr. C. I. Fletcher—Some Indictments.

The grand jury for the December term submitted its final report to Judge Alford, of the Criminal Court, yesterday.

Two hundred witnesses were examined, seventy indictments were returned and ten releases were ordered because of lack of sufficient evidence.

Dr. Calvin I. Fletcher, charged with attempted criminal assault; William H. Evans, charged with attempting to bribe election officers; Fred Zimmermann, illegal voting; John James robbery; P. W. Appleton, embezzlement; Glenn Miles, assault and battery to commit criminal assault; Joseph Blomberg, petit larceny and grand larceny; Harrison C. Bicknell, embezzlement.

Alice Parker was indicted on a charge of receiving stolen goods. It is alleged she received a watch said to have been stolen by "Bad-eye" Thomas from Bert Brady, 225 North Capitol street.

William Eakers, charged with stealing a copper kettle worth \$1.50, pleaded guilty to the charge of stealing a watch from Dorothy and Maud Donlon, which she pawned with Charles Medias on Indiana avenue. She entered a plea of not guilty.

Harry McAfee, indicted on a charge of assault and battery with intent to kill, also gave a plea of not guilty.

For Possession of Children. Judge Allen, of the Circuit Court, yesterday heard the petition of the Board of Children's Guardians for the possession of Ruby McNeal, eight years old, Lawrence McNeal, six years old, and Alice McNeal, four years old.

Boys Given Jail Sentences. Frank Lowery and Charles Morgan, two of the boy thieves who were recently arrested for robbing downtown offices, were each sentenced to forty days in the county jail by Judge Alford yesterday on charges of petit larceny.
