CIENER WINS HIS SUIT... THE JURY GIVES HIM A VERDICT FOR \$500 DAMAGES... The Twelve Men Deliberated for Twenty-Seven Hours - Schoppenhorst Demands an Investigation... After being out twenty-seven hours against the jury in the case of Isaac Ciener against the Indiana Wholesale Grocers' Association for \$500 damages yesterday afternoon returned a verdict for the plaintiff for \$500. Ciener alleged that the local grocers' association discriminated against him by purchasing manufacturers to not sell him tobacco. The loss to his business thus incurred he avers was \$500. An attempt was made to apply the Sherman anti-trust law in the case, on the grounds that the association manipulated its affairs as a trust and in violation of the law by its alleged discrimination, but this point was not permitted to be tried in court...
