WASHINGTON, Feb. 6.—For four hours to-day the Senate had the Philippine tariff bill under discussion. The measure was completed, so far as the Philippine committee is concerned, all of the committee amendments being adopted. Several other amendments, however, will be offered, one or two being pending. Toward the close of the session the discussion became heated. In response to a question offered several days ago by Mr. Rawlins, of Utah, the secretary of war transmitted to the Senate the sedition laws enacted by the Philippine Commission. They were read in full, and immediately drew the fire of the opponents of the government's Philippine policy. Mr. Hoar, of Massachusetts, expressed his astonishment that such laws should be enforced by the government authorities.

LYNCHED FOR ASSAULT

YOUNG NEGRO HANGED BY A MOB OF ENRAGED KENTUCKIANS.

His Victim a Popular Teacher at the Nicholsville Institute—Murderer Lynched at Lynchburg.

NICHOLSVILLE, Ky., Feb. 6.—Tom Brown, a negro, nineteen years old, accused of the murder of a white girl, was lynched to-day, after being identified by the woman. Brown was arrested last night and taken to the home of the victim, who recognized him, but to be doubly sure he was again taken to the scene of the crime this morning at 10 o'clock, in charge of officers, followed by a mob of two hundred armed men, determined that the prisoner should not be transferred to Lexington prison after the second identification. The mob followed closely behind the carriage in which the negro was handcuffed. This mob was reinforced by as many more, waiting at the jail for the officers and prisoner to return. As the carriage dashed up the mob surrounded it and set the officers and the negro, took him from the authorities, who were helpless, but made a strong resistance. He was hurried to the courthouse yard, two blocks away, where a rope was quickly put around his neck and thrown over the limb of a tree, when he was drawn up. He struggled to death and made no confession or statement. The whole city turned out, and all the women applauded at the end. There was no shooting.

Another Negro Lynched.

NASHVILLE, Tenn., Feb. 6.—Eulius Whittaker, colored, charged with the murder of John Doster, several weeks ago, was taken from jail at Lynchburg, last night, and hanged by a mob of whites. Whittaker was called in court yesterday and continued. At a late hour the mob appeared and, securing possession of the negro, hurried him to the courthouse. Whittaker was placed around his neck and he was hanged.

WILL REVISE PART OF CREED.

Statement by Clerk Roberts in Behalf of Presbyterian Committee.

PHILADELPHIA, Feb. 6.—To-day's session of the Presbyterian committee on creed revision was devoted almost exclusively to consideration of the report presented yesterday by the subcommittee on textual revision. The Rev. Dr. William H. Roberts, the stated clerk of the last General Assembly, who is a member of the general committee, gave out the following statement at the conclusion of the afternoon session: "The committee has decided tentatively to revise the doctrine of the final chapter of the Confession by declaratory statement, also, Chapter X, Section 3, on the salvation of infants; also Chapter XVI, Section 7, on good works. The other parts, Chapter XII, Section 3, on oats, and Chapter XXV, Section 6, on the limits of which all persons are to be considered, will be considered by the subcommittee of next meeting."

WASHINGTON, Feb. 6.—Following is the full text of the treaty between the United States and Denmark for the cession of the Danish West Indian islands, St. Thomas, St. John and St. Croix, which was recently negotiated between Secretary Gage on the part of the United States and Minister Brun for Denmark: "Article I.—"His Majesty, the King of Denmark, agrees to cede to the United States immediately on the exchange of the ratifications of this convention the islands of St. Thomas, St. John and St. Croix, with the West Indies, with the adjacent islands and rocks, comprising in said cession all title and claims of title to the territories in and about said islands over which the crown of Denmark now exercises, asserts, or claims jurisdiction. If they are removed they shall be placed in a less favorable position than that which they would enjoy if they remained in the island. "Those who remain in the islands may prefer their allegiance to the crown of Denmark by making before a court of record within two years from the date of the exchange of ratifications to this convention a declaration of their decision to preserve such allegiance. In default of which declaration they shall not after the lapse of said term of two years be a bar to their renunciation of their preserved Danish allegiance and their election of allegiance to the United States and admission to the nationality thereof on the same terms as may be provided according to the laws of the United States for other inhabitants of the islands. "The civil rights and the political status of the inhabitants of the islands shall be determined by the laws of the United States contained in the present convention. "Danish subjects not residing in the islands, but owning property therein at the time of the cession, shall retain their rights of property, but shall not be held to be bound by the laws of the islands in respect to such property, but shall be placed in this regard on the same basis as the Danish subjects residing in the islands and retaining therein or removing therefrom.

"Worth owned a steam yacht and the canvas was taken aboard and concealed there until he took the vessel to Lord Londale. Then he took the picture to Paris and finally brought it to America, where it was concealed for fifteen years. The picture was recovered in Brussels and forwarded to serve seven years. Mr. Pinkerton had known Worth for thirty years. Two years ago Mr. Pinkerton received a telegram telling him that an important letter was at his home. The letter was from Worth, who asked an interview. This was granted and Worth said he was going to die and wanted to "put up" a Gainsborough picture in order that his two children, who had been educated in a convent, might enjoy the proceeds. Through a hitch the picture was not recovered at that time. Worth returned to London and early last spring he fulfilled his bargain. "THREE OLD MEN MURDERED. "All Supposed to Have Been Killed for Their Money. "KANSAS CITY, Feb. 6.—Upon the discovery to-day of the dead body of George Zimmerman, a farmer sixty-three years old, at his home near Morris Station, six miles west of Leavenworth, Kansas, the Wyandotte county officers concluded that Zimmerman and two other aged men, all recluses, have been murdered in Wyandotte county since the first of the year by the same persons, and in each case it is believed the motive has been robbery. The body of Zimmerman was found in a well at his home near Morris Station. He had been dead nearly a week. "Danish subjects residing in said island may remain therein or remove therefrom at will, retaining in either event all their rights of property, including the right to sell or dispose of such property or its proceeds; and in case they remain in the island they shall not be held to be bound, provided, to enjoy all the private, municipal rights and liberties secured to them by the laws of the island. If they are removed they shall be placed in a less favorable position than that which they would enjoy if they remained in the island. "Those who remain in the islands may prefer their allegiance to the crown of Denmark by making before a court of record within two years from the date of the exchange of ratifications to this convention a declaration of their decision to preserve such allegiance. In default of which declaration they shall not after the lapse of said term of two years be a bar to their renunciation of their preserved Danish allegiance and their election of allegiance to the United States and admission to the nationality thereof on the same terms as may be provided according to the laws of the United States for other inhabitants of the islands. "The civil rights and the political status of the inhabitants of the islands shall be determined by the laws of the United States contained in the present convention. "Danish subjects not residing in the islands, but owning property therein at the time of the cession, shall retain their rights of property, but shall not be held to be bound by the laws of the islands in respect to such property, but shall be placed in this regard on the same basis as the Danish subjects residing in the islands and retaining therein or removing therefrom.
