LOCAL WHOLESALE TRADE. CONDITION OF QUIET EXCEPT IN GROCERIES AND PRODUCE. Fruits and Vegetables in Excellent Supply—Butter Market is Easier—Grains Quiet and Some Lower.

In most lines of trade the week ending on Saturday, Aug. 2, was very quiet. In the last week of July buying was light, and August is not far enough advanced to do much trading. Present conditions are not at all unusual to this season of the year; in fact, in some lines of trade the volume of business exceeds that of the corresponding period of last year. On Commission work more business is doing this year, for the reason that there are more fruit and vegetable available. There is there a year when melons and several varieties of berries have been more abundant than this year. The produce markets have been at their best, poultry and eggs much of the time selling in the luxury list, and butter, until the last few days, has been good property. But the bottom has gone out of the butter market, and prices are paying yesterday but 12 cents a pound. The decline is quite a disappointment to persons who have conceived the idea that with the action of Congress on oleomargarine prices of choice butter would be much advanced. Efforts of even home distributors of butter to advance price also failed. The market has a long time for a few weeks past, as usual during harvest time, but prices have not fluctuated to a great extent, staple articles at the close of the week being much the same as at its opening. The outlook for a good August business is very encouraging in all lines.

Indianapolis Grain Market. The local grain market at the close of the week was dull as compared with the early part, and with this weaker prices prevailed on all cereals. Receipts fell off the last three days of the week, with the lower prices which prevailed.
