While he admitted that a great deal of the testimony given by the witnesses for the prosecution was true, he testified that many of the accusations made against him were misrepresentations of fact. Two or three times Assistant Attorney Rand, by a severe cross-examination, apparently had Parks in an awkward place, but Mr. Osborne and the other lawyers for the defense were very watchful and their persistent objections to leading questions were invariably sustained by the court. Parks made no secret of his having received \$500 from the complainant, but he insisted that this money was paid in a legitimate business transaction with the Tiffany studios, the corporation on the complaint of which Parks' indictment in this case was secured.

Parks, while in poor health, seemed to be full of energy throughout to-day's ordeal. Several times the prosecuting lawyers attempted to get on record the fact that Parks had a bank account of a magnitude beyond the possibilities of an ordinary mechanic, but each attempt was overruled or cut short through the strenuous efforts of counsel for the defense.

When questioned by Mr. Osborne as to his having met some of the men who came to him from the Tiffany Company the accused insisted that he used the word "we," meaning the organization, whenever he spoke of the trouble between his union and the employers. He declared Parks' dealings with the Tiffany people were perfectly legal and invited the jury to look at Parks' mark which he highly nervous and delicate condition when he put him on the stand to testify in his own behalf. As soon as Mr. Osborne finished his opening the court took a recess. Parks took the stand as a witness in his own defense at the opening of the afternoon session.

MINERS CELEBRATED

THEY LEFT THEIR MARKS.

Levins and Clarke Cut Their Names on a Tree in 1804.

BAKER CITY, Ore., Oct. 29.—Dr. H. E. Curry, of this city, reports the discovery in the Mount Rasmus mining district of a tree bearing the inscription: "Levins and Clarke, 1804." The inscription was found on a tree about the size of a log house. The inscription on the tree was in the late fall or winter months when the sap was down. It is known that one of the earliest overland trails passed near the scene of the discovery reported by Dr. Curry.

WALKING DELEGATE ON THE WITNESS STAND IN OWN BEHALF.

He Admits that Much of the Evidence Against Him is True, but Says Some is Misrepresentation.

CONFESSES RECEIVING \$500 BUT INSISTS IT WAS NOT EXTORTED FROM THE TIFFANY'S.

Declares the Money Was Collected as an Initiation Fee—Testimony of Other Witnesses.

NEW YORK, Oct. 29.—The trial of Samuel J. Parks, walking delegate of the Housemiths' Union, No. 2, on the charge of extortion, probably will be concluded tomorrow. Judge Newburger, before whom Parks has been on trial since Monday, stated this evening that he would endeavor to bring the trial to a conclusion before Saturday.

Parks was a witness to-day. While he admitted that a great deal of the testimony given by the witnesses for the prosecution was true, he testified that many of the accusations made against him were misrepresentations of fact. Two or three times Assistant Attorney Rand, by a severe cross-examination, apparently had Parks in an awkward place, but Mr. Osborne and the other lawyers for the defense were very watchful and their persistent objections to leading questions were invariably sustained by the court. Parks made no secret of his having received \$500 from the complainant, but he insisted that this money was paid in a legitimate business transaction with the Tiffany studios, the corporation on the complaint of which Parks' indictment in this case was secured.

Parks, while in poor health, seemed to be full of energy throughout to-day's ordeal. Several times the prosecuting lawyers attempted to get on record the fact that Parks had a bank account of a magnitude beyond the possibilities of an ordinary mechanic, but each attempt was overruled or cut short through the strenuous efforts of counsel for the defense.

USED THE WORD "WE."

When questioned by Mr. Osborne as to his having met some of the men who came to him from the Tiffany Company the accused insisted that he used the word "we," meaning the organization, whenever he spoke of the trouble between his union and the employers. He said that he may have cured. He denied that he had told Schmitt that the money was for himself. He said that the money came to him first and then he turned it over to the organization. He referred to the reference to District Attorney Jerome Parks said that he said to Schmitt that "stark" could employ him on small jobs, as they could do it easier than on jobs where many mechanics were employed. He said that he had told Schmitt that Tiffany studios had been the \$500 that Tiffany could come to him at his home.

THE LINE OF DEFENSE WAS UNCOVERED WHEN PARKS, IN ANSWER TO OSBORNE'S QUESTION, SAID THAT HE PAID THE \$500 TO PRESIDENT JOHNSTON OF THE UNION. MR. OSBORNE DRAMATICALLY STOPPED OSBORNE TO "STAND UP," SHOUTING OUT THE REQUEST AS HIS OWN DESIRE TO GO ON WITH HIS OWN CROSS-EXAMINATION.

Mr. Rand, in cross-examination, asked the witness whether the men stopped work on the Tiffany jobs of their own accord, and Parks said: "I did not tell them. I did not call the strike." When reminded of his testimony at the Piety trial that the rules and regulations of the union did not allow men to go on a strike of their own accord, Parks said that he had not called on men to
