PARIS, April 27 .- The St. Peterscorrespondent of the Matin "I learn from a sure source that the Vladivostok squadron yesterday sank four Japanese transports which were conveying 4,000 men."

LIAO-YANG, April 26.-Between last night and this morning the Japanese forced a passage of the Yalu, two companies crossing between Tchangdjiou and Sinopoussikhe. It is believed the Russian fire succeeded in destroying the floating parts of the Japanese bridges.

JAPANESE MAY TRAP THE RUSSIAN SHIPS

LONDON, April 26.-If the plans of the Japanese Admiralty do not miscarry there soon will be no Vladivostok squadron to worry the Mikado's transports or harass towns on the Korean coast. Until the Vladivostok squadron descended on Gensan yesterday its whereabouts was not definitely known. When news of the sinking lated once more reports that efforts were of the Goryo Maru, a small transport, reached Japan, the Admiralty was prompt in taking action. Exactly what was done is not known, but it is believed at Tokio that the retreat of the squadron to Vladivostok has been cut off-that if the Russian ships attempt to reach home they will find part of Admiral Togo's fleet barring the way and that if they try to make Port Arthur the remainder of the Japanese fleet will put an end to them in quick order. It is a case of "twixt the devil and the deep sea," in the view of English naval trategists, but the Japanese do not put that way. They say the Russians and their ships will be claimed by both the deep a and the ruler of the nether regions. Franklin, of Company H, Second Regiment, Indiana National Guard, two months ago, the commission of that officer has been revoked by order of Governor Durbin, and he is no longer in the service of the State. The general order relieving Franklin of his command and placing the company temporarily in the charge of First Lieutenant Albert Smith was issued from the office of the adjutant general Monday

The order, which comes as a result of the examination by the special board of investigation of the affairs of Company H, reads

"For neglect of duty in the management of the civil and military affairs of his company, and for conduct in the management of his company prejudicial to good order Captain Harry M. Franklin, Company H. Second Regiment, I. N. G., is hereby re-

The board, which was composed of Maj. J. J. Backman, of Aurora; Maj. W. J. Coleman, of New Albany, and Maj. J. B. Coulter, of Vincennes, did not recommend a revocation of the commission, but the action was taken after a report had been
