

THE NATIONAL TAX.

The schedule of the Tax Bill, signed by the President, is as follows: The Duties on Incomes, Insurance Companies, Railroad Companies, etc.—The Taxes on Distilled Spirits, Manufactures, Oils, Paper, Glass, Candles, Tobacco, Snuff, Gunpowder, etc.—The Duties on Leather, Hides, the Wine, Coal, etc.—The Tax on Cotton, the Lumber, etc., etc.

The Tax Bill just passed both Houses of Congress on the 23rd of June. We give here a table of the taxes imposed. The names of the articles and classes of property taxed, are arranged in alphabetical order, referring to the schedule for complete details.

The taxes imposed are of the following different classes, viz: First—A tax on persons and corporations engaged in certain pursuits, for license.

Second—A tax on manufactured articles, products, etc., to be paid by the manufacturer or producer when the goods are produced.

Third—A duty on companies, individuals, railroad and steamboat companies, public officers and others.

Fourth—Duties on imports, to be paid by the importer, to be affixed to certain papers, medicines, documents, etc.

Fifth—A tax bill is to go into effect on the first of August. A large portion of the people of the Northern States will be taxed on the income of the year preceding.

The President may divide the States into districts, not exceeding the number of congressional districts, and appoint an assessor and collector to be confirmed by the Senate.

The assessor shall divide the taxable property of each district into convenient sub-districts, and appoint an assessor in each sub-district.

Each assessor may appoint an assistant collector, who shall be responsible for acts of his collectors.

Persons refusing to furnish a list of their taxable estates and incomes to be taxed, or who refuse to be assessed, are authorized to enter dwellings and places, to ascertain the amount of property owned.

The assessor may hear appeals, but shall not increase assessments, without first giving notice to the assessed party.

The collector shall give notice by advertisement or personal notice, to the owner of the property, and if he does not pay the tax, the assessor shall add to the amount assessed, a penalty of ten per cent.
