Should a vacancy occur in either of the three offices subsequent to the election, it shall be filled by the Governor, and the person appointed shall continue in office until the expiration of the term for which he was elected.

Mr. St. Paul offered the following amendment to be inserted after the word "unless sooner removed":

"But the Legislature may provide by law for a greater number of Sheriffs and Clerks in the Parish of Orleans."

### Arrival of the Falcon.

The steamer Falcon, Lieut. Rogers, U. S. N., commanding, arrived yesterday from Aspinwall, the 25d, and San Juan the 26th ult., bringing California dates to the 1st of July.

Lieut. Rogers reports that the steamship Columbus, from San Francisco, arrived at Panama, on the 20th ult., with eighty-eight passengers, and the mails of the 1st of July.

The Falcon brought twenty-two of her passengers to this city. The rest took passage on the Sierra Nevada, for New York.

Lieut. Rogers says that everything was very dull on the Isthmus. The Falcon put into San Juan de Negras for passengers.

The following vessels were in port at Aspinwall on the 25d: ship *Albatross* and bark *Vulture*, discharging coal—the latter to sail for New York on the 26th ult.

Arnold Chappouier, a passenger, belonging to New Orleans, died on the evening of the 25th ult.

DIFFICULTY IN THE MINES.—*Expulsion of Foreigners*.—The San Francisco Herald publishes a letter, dated at Stockton, June 27th, which says:

A Spanish gentleman, named Don Jose de Llaguno, arrived this morning from Mariposa, and states that he and about fifty other foreigners, comprising Spaniards, Chinamen, Manillans, and others, were expelled from the mines on the 25th of the month, from the claims they had been working for the last few months, and which were just beginning to pay. He had erected machinery at a cost of \$1,800, and had to abandon all to save his life.

The cause of this has been the fact that, at the crossing of the Agua Fria and Fresno roads, at which it was required to expel all foreigners from the district, and under no other authority than the resolutions passed at this meeting, have these poor mechanics been forced to abandon their works, and Mr. Llaguno's life saved him on condition of his immediately leaving the State of California.
