THREE DAYS LATER FROM EUROPE. ARRIVAL OF THE STEAMSHIP EUROPA.

NEW YORK, April 18.—The Cunard steamship Europa, Capt. Leitch, arrived at this port this morning.

She left Liverpool on Saturday, the 2d inst., and brings advices from London and Liverpool three days later than were received by the City of Baltimore.

The steamer Europa, of the New York and Bremen line, arrived at Bremen on the 31st of March, and her American agents published in Liverpool on the 1st of April a favorable effect upon the cotton market.

The latest phase of political affairs on the continent is rather discouraging as to the prospect of a nice settlement of the Italian question.

Austria has refused to accede to the proposition of the other great powers, to assemble a congress at Baden, for the purpose of adjusting the existing difficulty between France and Austria.

Nothing decisive has transpired in regard to the time and place of holding the peace congress, which is still spoken of as certain to be convoked.

In the British Parliament the Ministerial Reform bill was passed on a vote, and the ministry were defeated by 59 majority.

The ministry had not yet resigned, but it was expected they would do so.

The Irish session trials at Tralee resulted in the conviction and sentence of the prisoners to ten years' penal servitude.

The trial of those arrested on the same charge at Belfast, Ireland, had been concluded.

The jury disagreed, and were locked up till they should come to some agreement on a verdict.

The departure of the steamship Prince Albert from Galway had been postponed to the 9th of April.

France has consented to leave the choice of the locality of the Peace Congress to Austria.

Piedmont is to be admitted to the Congress on the same footing with that of the other Italian States.

Count Cavour, the Italian Prime Minister, had returned to Turin from Paris, and it is said that he has secured the object he had in view in visiting Napoleon.

The military preparations of France and Austria are continued with apparently the same warlike aspect.

The Paris Bourse closed firmly at 48 francs 6 centimes.

Advices from Rio de Janeiro, by the Europa, state that a new commercial treaty had been negotiated with Paraguay.

Commercial Intelligence. LIVERPOOL, April 2.—The total sales of cotton during the week foot up 63,200 bales.

The sales to speculators during the same period amount to 9,600 bales, and the sales to exporters were 10,000 bales.

The market closed firm, and there was a good demand for cotton. The quotations of last Saturday by the Canada have been fully maintained.

Holders are offering their stocks freely but show no disposition to press sales.
