Arrival of the Africa at Halifax. THE CONTINUED SEARCH FOR STEPHENS. REFORM BILL IN PARLIAMENT. THE STATE OF SIEGE STILL CONTINUED IN SPAIN.

HALIFAX, March 15.—The steamship Africa, from Liverpool on the 2d, via Queenstown on the 4th inst., has arrived at this port. Her dates are two days later than those already received.
