There has been an active demand noticeable to-day and prices remain unchanged. Sales include 250, 400, 1000 and 1500 sacks, at \$1.15 per 100 lbs.

There is no demand for any kind of cotton in this article. The supply on hand is fair, demand limited, and prices for round lots nominal. In a retail way there has been moderate business, doing at 25c to 35c bid.
