A Platonic Attachment Made Returnable to Court.

ENGLAND ABANDONS ALL HOPE OF MAXIMILIAN'S THRONES—THE COMING ASSASSINATION OF THE COUNTRY BY THE UNITED STATES.

From the London Times, Sept. 12. The year 1868, which has been so fatal to German thrones, will witness also the collapse of a more modern monarchy in the New World. It is not to be dissembled that the Mexican empire is a hopeless failure, and that the empire founded in the capital of the Aztecs by Napoleon III, has withered away without so much as taking root in the soil.
