New Orleans Money Market.

The feature of the market to-day has been a slight softening of rates on Gold and Foreign Exchange, which was exclusively due to the fluctuations of the New York market.

FRANCIS—We have no sales to report to-day, but continue to quote prices for our day at \$21 50/22, and ordinary St. Louis at \$22 25/23 per ton.

INDIA—There is some little inquiry for this article and sales were made of 25 bales at \$30 per yard.

WOLLEN—There is a fair demand for the new crop, which is selling at 65 7/8.

COFFEE—There were sales to-day of 150 bags at 19 1/2 cts. per lb.

WHEAT—There is no disengaged tonnage on both for either New York or Boston, and rates are firm as follows:
