BURLINGAME DINES THE PRESS.

WASHINGTON, July 18.--The Southern representatives conducted themselves quietly, voting with the radicals on all questions. Their prompt party votes on subjects which have been seriously discussed for months, and upon which the most shrewd legislators are doubtful, provoke smiles on the floor of either House.

It is stated that the three hours cabinet session yesterday was very important, and that some executive suggestions regarding the presidential election will be sent to Congress to-day, and that the veto of the bill regulating the electoral college will be withheld until Monday.

The Senate last night passed the Alaska treaty with an amendment ignoring the joint power of the House and the State and President in making treaties of either House.

It is stated that the Senate simply appropriated the money to fulfill the stipulations of the treaty.

The Senate also passed bills providing for selling the St. Louis arsenal property; adding improvements in the Mississippi River at Rock Island and Des Moines rapids; exempting cert in vessels trading with Canada from tonnage fees, and the civil appropriation bill.

The House considered the funding bill.

The following is a synopsis of the president's message which was read to Congress to-day:

Quoting Gen. Jackson in support of his views, and arguing that by the present system the will of a majority of the people is liable to be defeated in the choice of a president, he favors the election of state senators by the people instead of by the legislature, and a limited instead of a life tenure of Supreme Court judges, pointing out the interest the chief justice and vice president have in cases of presidential impeachment.

The president closes his argument as follows: "Time, observation and experience have confirmed these convictions, and as a matter of public duty, and with a deep sense of my constitutional obligation to recommend to your consideration, I submit the necessary for your consideration, and I submit the accompanying propositions, and urge their adoption and submission to the judgment of the people."

The president proposed the following amendments to the Constitution:

The president's term of office shall be for six years.

The States shall be divided into equal districts, corresponding with the number of representatives and senators within said districts, receiving the vote of the district.

These facts shall be certified to governors of States, to the president of the United States, and to the president of the Senate, and to the president of the House of Representatives, and to the president of the Supreme Court, and to the president of the State legislatures, and to the president of the State courts, and to the president of the State bar, and to the president of the State press, and to the president of the State people, and to the president of the State world.

The federal Congress shall be in session on the second Monday in October, 18-- and every sixth year thereafter, and the president of the Senate, both houses present, shall open and count the votes for the second time. In case of a tie, the president shall be president and vice president respectively, if they have a majority of the votes cast, otherwise the second election occurs between the two highest for each office. If at the second election both receive a like number of votes, the candidate receiving the highest number of votes in the largest number of States shall be president. The same rules shall apply to vice president, but in case of a second election being necessary, the Senate shall elect a vice president from the two candidates receiving the highest number of votes of districts. No president or vice president shall be eligible for a second term. In case of removal by the president, the office devolves on the vice president, and in case of the vice president's removal, the presidential office devolves on the secretary of State, following whom, as successors, come the secretary of the treasury, the secretary of the navy, the secretary of the interior, the postmaster general and attorney general, who shall exercise the functions of office until the disabilities are removed or a new election held.

The Senate of the United States shall be composed of two senators from each State, chosen by electors of the State legislature, to hold six years each having one vote.

Judges of the supreme and inferior courts shall hold twelve years.

The president, after the adoption of the proposed amendment, shall divide judges of the Supreme Court into three classes, expiring the fourth, eighth and twelfth year, so that one may be chosen every fourth year.

The applications of the Georgia and Mississippi conventions for loans were immediately postponed.

The bill authorizing corporations created by federal authority to bring suits in federal courts, passed.
