There is no improvement to notice in the Alabama crops. Accounts from the country continue bad. The Clinton (La.) Patriot of the 21st says: "The worst dry weather for the past two weeks has been here in the State. In the cotton fields it is open rapidly, and planters are now busily engaged in picking. A continuance of favorable weather for two weeks more will put a large amount of cotton out of the ground."

The weather is pretty wet, but the cane grows rapidly and bids fair to give a generous yield. There is plenty of food in the country. On Cote Blanche (left) and the management of Mr. Strawbridge, the cotton crop is uncommonly good. No worm but the grass worm has made its appearance, and that is only an enemy to grass. Mr. P. H. Hunt, Jr., of the latter part of July, and could have sent a bale to market on the 31st ultimo, which would have been the first new cotton sent to market in the month.
