MADRID, Sept. 21.—The decree accepting Gonzalez Bravo's resignation named Gen. Jose Concha president of the council.

This morning's Madrid Gazette announced that a revolt had occurred at Cadix and Seville.

The government has ordered the army into three great divisions, comprising Catalonia, Castile and Andalusia, under Gens. Penela, Manuel Concha and Novalesches.

A provisional government has been formed in Seville, with Espartaco as president.

The strength of the insurgents is 4000 soldiers, 15000 men and 10000 arms.

The revolt progresses at all points. Isabella left San Sebastian at midnight on the 20th for Madrid.
